I am providing testimony in strong opposition of HCR 163. Foremost is the absence of any communication with the School of Social Work on the establishment of a Center of Social Work. Our Hawaii Chapter is planning an expansion of this Center to focus on trends and issues in our State. We need to collaborate with the School of Social Work on duplicity and whether placement of a Center would be appropriate at the School of Social Work or in the community where social workers practice.

#### **POSITION- OPPOSED**

Aloha, my name is Roberta Williams and I am a School Social Worker with the Department of Education. I am testifying in opposition to HCR 163/HR 136 which is proposing to establish a Center on Social Work at the University of Hawaii.

- I do not feel that the Legislature need establish a Center for Social Work as there are several entities already in existence that provide a very similar function. The following are three examples:
  - the NASW already has a Center on Workforce Studies which 1) conduct studies of the current social work labor force as well as collect information from other sources in order to serve as a clearinghouse for educators, policy makers, social workers, and public and private work force planners; 2) enhance social work professional development through innovative training programs in emerging practice areas; and 3) disseminate timely information and resources on evidence-based practices.
  - 2. In addition, The University of Hawaii School of Social Work already has the Social Work Evaluation, Research and Training Unit (SWERTU) whose mission is "to meet the evaluation, research and training needs of programs in the state of Hawai'i that address social welfare issues.
  - 3. Another Center established by the UHM-SSW is called The Center for Training and Evaluation Research of the Pacific

(CTERP). This center is designed to advance the profession through research, evaluation, and training with a sustained commitment to the development, functioning and resilience of the people, communities, and agencies of Hawai'i and the Pacific, the nation, and the world.

While I firmly believe that research and evaluation are vital to the Social Work profession and to ensuring our continual commitment to addressing the needs of our community, establishing another research center may not be the best use of resources.

Having recently visited the School of Social Work at Manoa, I was appalled at the location of our School. The building in which the School of Social Work resides is condemned. I was told that the professors and support staff have been housed in these condemned buildings for 7 years. If we truly value our Social Workers and the School of Social Work, it would go a long way in showing support by providing our faculty and staff with decent office space rather than creating yet another center to do yet more research.

I am a State of Hawaii Government employee. As such, I am exempt from securing a Social Work license. I voluntarily got my license because I believe that it establishes a level of professionalism that builds respect and confidence for my profession. To suggest that we should fund this new Center for Social Work through the increase of licensing fees is not appropriate and somewhat discriminatory in that not all Social Workers are required to have a license.

As such, I am opposed to the passage of HCR 163/ HR 136 Supporting the Establishment of a Center on Social Work at the University of Hawaii at Manoa School of Social Work and ask that you reject the passage of HCR 163/HR 136.

Chairman Chang and Members of the Committee on Higher Education,

My name is Dr. Jon Matsuoka, I am the Dean of the UHM School of Social Work and I am testifying today in relation to HCR 163 and HR 136, regarding the establishment of a Center on Social Work at the University of Hawaii at Manoa School of Social Work.

First, I would like to thank Representative Chang and the other co-sponsors of these resolutions for their support of the School of Social Work and for the concept of a Center on Social Work. As stated in the resolutions, there has always been a serious dearth of meaningful data in this state in areas such as workforce status and needs in social services, program and practice effectiveness, capacity building, and social policy development. The kind of research that could be done through this center would be invaluable to the social work profession in Hawaii, to decision and policy makers, and to the community as a whole.

That said, the UHM School of Social Work has had some initial discussions on the matter with the Hawaii Chapter of the National Association of Social Workers and it has been mutually agreed that we should continue the dialogue, with the possibility of expanding the scope of participants in that discussion. We are also in agreement that the mechanism for funding the Center on Social Work, as described in the resolutions, is not feasible at this time.

I would therefore request that HCR 163 and HR 136 be held in committee and not be passed on for further consideration.
