The City and State are responsible for providing a clean environment within their jurisdictions and permit the public at large to participate in endeavors to maintain such conditions.

However, the Navy, the predominant land owner along the banks of both West and Middle Lochs, has permitted abandoned vehicles, and other white goods illegally discarded to remain on the landscape for decades.

By the military properly disposing of these items and removing them from the landscape will enhance the efforts undertaken by the volunteers working on other sensitive environmental sites that abut military property such as the 70 acre Pouhala Marsh and Kapakahi Stream nearby.

In addition, addressing invasive species for removal (encroaching from military property onto endangered wildlife areas) is a sound practice for the State of Hawaii to employ and do so in unison with all property owners to achieve the results sought.
