history of labor in Hawaii and suggest ways this might be accomplished. In addition, the Department will provide a list of resources that teachers may use in the classroom. The Department recognizes the important role labor has played in our state's history and will support and encourage teachers to provide educational learning experiences consistent with the HCPS III.
