In the nearly eleven years of his service with the Office of the Public Defender, Mr. Bartholomew has been assigned to represent clients in the district court and for eight to nine of those years he has also represented our juvenile clients in the Family District Court.

During that time, Mr. Bartholomew has been a dedicated and effective counselor and advocate for both his adult and juvenile clients.

Mr. Bartholomew has proven that he is skilled attorney. I have never hesitated to assign Mr. Bartholomew any case in the District or Family District Courts. I have never been concerned about the level of commitment or expertise Mr. Bartholomew has provided to his assigned clients.

In addition to advocacy of individual clients, I have also relied upon Mr. Bartholomew to shoulder certain administrative duties of this office including, the training and mentoring of recent public defender hires assigned to the district and family district courts, and as our representative in administrative meetings and conferences on issues involving the judiciary and the criminal justice system.

Mr. Bartholomew has work with the judiciary in the planning and implementation of changes within the court system for the improvement of services to the public. Mr. Bartholomew was assigned these administrative duties because he possessed the knowledge and ability to cooperatively address the issues of these programs.

Mr. Bartholomew possessed the intelligence and thoughtfulness necessary to represent our concerns in any discussion involving our role in the judicial process.

This confidence in Mr. Bartholomew's considerable abilities is shared within the larger legal community. I understand that Mr. Bartholomew has broad support of many in the judicial system, from judges, fellow lawyers and court personnel.

Mr. Bartholomew possesses those qualities necessary for the position as a Family District Court Judge.

Mr. Bartholomew is a member of our community. He has lived and worked in Hawai'i since his graduation from law school. However, Mr. Bartholomew also has had the advantage of growing up, going to school and working on the mainland. I believe that these experiences have added to Mr. Bartholomew's appreciation of this state and our community.

Dear Committee of Judiciary and Labor,

I am writing in support of the confirmation of the nomination of Anthony K. Bartholomew (Tony) as District Family Court Judge of the Third Circuit. My first professional contact with Tony was in the 1980's when he was a presenter in a seminar on motions practice that I attended. He was an associate of Hart & Wolff at the time.

Tony went on to become a Deputy Public Defender in Hilo where he chose to practice primarily in the area of juvenile law. Over the years I have represented clients in the Third Circuit and have had many opportunities to consult with and seek advice from The area of juvenile law is vastly different from that of criminal defense of adults. The successful practice of juvenile law requires zealous advocacy of a minor's rights and legal knowledge but it also requires a blend of knowledge and skill from disciplines other than law. A successful juvenile attorney must sometimes act as a social worker for the minor. Minors often times have problems other than legal ones. Sometimes the legal problems are of the least concern to the minor. The minor must trust the attorney not only to represent him/her but also to be a confidant and counselor. A successful juvenile attorney must sometimes act as a problem solver or mediator. Many times the representation of a minor involves the participation of other state agencies such as the Department of Health, the Department of Education and the Department of Human Services, not to mention the Prosecuting Attorney or Attorney General. Getting various governmental agencies to agree on a course of action is easier said than done and it is up to the attorney to gain a consensus for the benefit of the minor. Due to the emotional commitment, the successful and continued practice of juvenile law requires an attorney who cares about people and society as a whole. Without the emotional commitment, the practice of juvenile law would burn out the ordinary attorney. Because Tony has chosen to devote his legal practice to juvenile law, it shows his concern for the state's

future.

Due to his knowledge and his desire to serve the public, Tony was a member of the planning team of the Drug Court in the Third Circuit. He later became a member of the planning team of the Juvenile Drug Court. These teams were responsible for the implementation of the Drug Court programs from ground zero and involved members from judiciary, probation and prosecution. This further demonstrates Tony's commitment to people and society.

While Tony may not have worn the "black robe" before, he has definitely received years of on the job training. As a District Family Court Judge, Tony will continue to demonstrate his legal knowledge, his social worker/counseling skills and his problem solving/mediator skills. I whole-heartedly support the confirmation of Anthony K. Bartholomew as District Family Court Judge for the Third Circuit.

Dear Senators Taniguchi, Hee, Kokubun, Nishihara, Gabbard, and Slom:

I am pleased to provide your committee with testimony in favor of the confirmation of ANTHONY K. BARTHOLOMEW as Judge, District Court of the Third Circuit, State of Hawaii.

I have practiced as an attorney in the State of Hawaii for the past 20 years, and over the past year, I have served as a *per diem* District and Family Court Judge in the Third Circuit, State of Hawaii. Although my testimony in favor of Tony Bartholomew is based largely on my perception gained in the capacity as a sitting judge, I would like to make clear that I am writing this letter solely in my capacity as a private attorney.

For approximately the past eight to ten years, my practice has focused almost exclusively in Family Court, the very court to which Mr. Bartholomew would be assigned if confirmed to this position for which he has been nominated by the Judicial Selection Commission and appointed by the Chief Justice. As a long-time Family Court practitioner, I believe I have a keen insight into the qualities that a person must bring to the office of Family Court judge.

The Honorable Karen Radius, an excellent Family Court judge sitting in the First Circuit, once told me that the job of Family Court judge is not always just judging, but at times also part social worker, counselor, and perhaps even priest. In other words, this position requires that a person have not only a strong understanding of the law, but also a sincere interest in people, their lives and families, and an ability to communicate with them.

I have observed Tony Bartholomew to have these traits. During my assignments as a per diem judge, Mr. Bartholomew has appeared before me many, many, times. Due to his heavy caseload as a Public Defender, I think it would be fair to say that Mr. Bartholomew has handled literally several hundreds of cases before me. This has given me an opportunity to observe Tony

from the unique perspective afforded from the bench, during court proceedings, pretrial proceedings and settlement conferences.

First and most importantly, Mr. Bartholomew is highly competent both in his knowledge of the law, and his technical courtroom skills. It is clear Mr. Bartholomew studied and understood the law, and how it applied to his clients. He was also comfortable in court, and had a good command of important technical skills such as processing cases, examining witnesses, courtroom etiquette, and the rules of evidence.

Mr. Bartholomew also has an excellent, patient, and calm demeanor, which will serve him well as a Family Court judge. Finally, I have watched Mr. Bartholomew's interaction with his clients, who are at times very challenging. He treats them respectfully, intelligently, and with appropriate comfort and sense of humor such that he is able to put them at ease, and assist them to reach sensible case outcomes. These traits will be put to good use on the Family Court bench, which seems to me to be the most difficult judicial position to which an applicant can be appointed.

In closing, I am pleased to be able to testify from my own experience and observations of Mr. Bartholomew that he will be an excellent Family Court judge, and that he will serve the Hilo community extremely well. I urge this committee to recommend his confirmation as a District Court judge.

The Board of Directors of the Hawaii State Bar Association appreciates the opportunity to comment on the qualifications of Anthony K. Bartholomew for the position of Judge, District Court of the Third Circuit.

In evaluating judicial nominees, the HSBA Board utilizes a modified version of the American Bar Association Guidelines for Reviewing Qualifications of Candidates for State Judicial Office. These Guidelines include the following criteria: integrity, legal knowledge and ability, professional experience, judicial temperament, diligence, financial responsibility, and public service, collegiality and writing ability. The HSBA Board's rating system includes the categories of "highly qualified," "qualified," and "not qualified."

The HSBA Board has recently reviewed the policies and procedures utilized in developing its positions on judicial nominees and has included in its procedures the use of a standing subcommittee of HSBA Board members to review materials presented by the nominee and input from members; the subcommittee is also tasked with checking references and contacting others who have knowledge of the nominee's experience and qualifications. The full Board reviews the materials prepared by this subcommittee, the complete materials submitted by the nominee and members and conducts an interview of the nominee. These revised procedures are available for review on the HSBA website at <HSBA.org>.

Taking into consideration all of the information presented by and about the nominee and an interview with the nominee, the vote of the Board of Directors of the Hawaii State Bar Association found Anthony K. Bartholomew to be qualified for the position of Judge, District Court of the Third Circuit.
