RELATING TO CABLE TELEVISION SYSTEMS

Chair Nishihara and members of the Committee, thank you for the opportunity to testify on S.B. 1789.

The Department of Accounting and General Services (DAGS) understands the desire of existing providers of public, educational, and government (PEG) access service to not have to compete for the contracts that the Department of Commerce and Consumer Affairs (DCCA) would award. There have been petitions before the Procurement Policy Board pleading that the procurement of such services should not be subject to the procurement code. Those petitions have been denied.

The application of the procurement code is specified in 103D-102, HRS, which states:

§103D-102 Application of this chapter. (a) This chapter shall apply to all procurement contracts made by governmental bodies whether the consideration for the contract is cash, revenues, realizations, receipts, or earnings, any of which the State receives or is

owed; in-kind benefits; or forbearance; provided that nothing in this chapter or rules adopted hereunder shall prevent any governmental body from complying with the terms and conditions of any other grant, gift, bequest, or cooperative agreement.

103 - 102 (b), HRS goes on to describe procurements that are exempted from the procurement code. In being moved into law, arguments were made that established that these procurements were not advantageous or not practicable for the State or Counties.

Absent a compelling showing that procurement of access service management contracts are not advantageous or not practicable, the DCCA, a government agency, is fully subject to the procurement code.

DAGS does not believe that this bill presents a compelling argument for exempting access services management contracts from the procurement code.

Aloha, my name is Naturalee Puou, and I am writing to provide written support of Senate Bill 1789 and of 'Ōlelo Community Television as well. I was first introduced to 'Ōlelo through its Wai'anae facilities when I was fifteen years old and in the ninth grade. I volunteered to help film various community events and participate in their youth programs for almost two years. Nearly five years later, I now work as a College Intern at the Wai'anae 'Ōlelo Community Media Center, so I take no offense if you were to assume that I grew up in Wai'anae 'Ōlelo.

Despite my length of time with the organization, the value of public access was not made clear to me until it was recently threatened throughout the state. As I'm sure you are already aware of, 'Olelo Community Television has been fighting the RFP Process for nearly two years now, and I along with my fellow interns have been standing with them in the fight. A lot of people feel that this RFP Process would be a good thing, but I severely question if it would be for the "greater good". While those in opposition of the services that 'Olelo offers have been determined in pointing out all of the organization's flaws, I believe it is more important to look past the things that tempt us to ridicule the way ('Olelo) we receive something as wonderful as free speech through public access, and to focus on the bigger picture: getting our voices heard. It's why 'Olelo exists in the first place, after all. Not because of some agreement between the people and Oceanic Cable, and certainly not because it was something "cool" to have around. Those certainly aren't the bigger picture. 'Olelo exists for the people of O'ahu; to be seen, to be heard, to be free in voicing their opinions.

It took me five years to realize how lucky we are to have public access and community television. It took me five years to realize how lucky the people of O'ahu are to have 'Olelo! As a resident of Waianae, I believe that I can speak for a large portion of my community when I say that this is an organization cherished by the people as one of our own family members. And as an example, when family members make mistakes throughout their lives or when they make bad choices, it is not the Hawaiian way to get rid of the person and put their place in the 'ohana up for bid! The Hawaiian way is to make sure they learn from their mistakes and improve, as there is always room for improvement. Therefore, if 'Olelo loses its contract in a bidding process, how can it fix things and prove to the communities that it is worthy of providing services? I believe S.B. 1789 will offer them that second chance.

In the beginning of this drawn out RFP process, my stance was that in support of 'Olelo Community Television, public access on O'ahu wasn't broken, so there was no need to fix it. Two years later, I still support 'Olelo Community Television, but I am sure that it can be improved despite not being broken. S.B. 1789, I am confident, will give the organization the security it needs to be better. Mahalo for your time.

My name is Pastor Sally Jane Amina and I have a program on Channel 52 with Olelo called, "Have Faith In God." As a community member I am grateful to be able to use the facilities and equipment available to us, as well as take advantage of the ever-present assistance by staff, interns, volunteers, clients and others. It was not always like this.

In the beginning – before Olelo as the current PEG access provider, when my husband and I first started our program in 1989 we had to go all the way to town in order to make a 15 minute program every week. After a time we went to the old Sony to record our program, which was scaled down to only 5 minutes, and then after a couple of months we went through technology classes to learn to use the camera equipment as well as attend a producer's course. In order to become licensed we had to complete a project as a class. Once we were licensed we were able to borrow the equipment and do our own taping; however, we did still have the challenge of traveling to town every week, having to find a place to do our filming at, returning equipment back to town and doing our editing in town, too. By this time we were able to do a 30-minute program each week.

I share all of this with you so that you know I understand the value and importance of PEG access and having the right provider in place. PEG access cannot only be about programs, although that is the medium we use as the voice of our community, but PEG access must also be about building and nurturing a community and all the relationships within it.

That is why I support Bill no. 1789, because although the director will still be responsible for designating an access organization and the requirements it must meet, it also states that the 'terms and conditions upon which requirements for the designation is provided are fair to the public, taking into account the geographic, topographic, and economics of providing cable access in the service area.' (Section 1.c.)

Also, I believe that PEG access and the designation of its provider should not be based upon the best bid, but upon the best qualifications of the access organization to meet the needs of the community, the goals set for future growth as well as to provide the necessary facilities, equipment, training, support and fellowship between staff and volunteers that best serve the needs of the communities PEG access exists in. (Section 1.e.)

Greetings and aloha to you all. I am writing today as a Wai'anae resident, an 'Olelo client, a native Hawaiian, and a concerned citizen. My name is Ms. Sharlette L. K. Poe, Jr. and I am here to relate to you my travels along this road called PEG access on a vehicle called 'Olelo.

I started as a client with 'Olelo for our church organization, Ark of Safety Christian Fellowship in Wai'anae, exactly three years ago on February 11th. As you know a lot can happen in three years, and so much has in public access as a whole and with 'Olelo. I had only peripheral experience with public access and no real understanding until I came to the Wai'anae 'Olelo facility and took the classes and met the people. It was while I struggled to quickly learn and implement my new skills for our church projects that I realized the people here are what made the experience great. They helped me to get through the bumps and barriers in my progress with PEG access, and helped to grow my confidence in using the equipment.

In fact, they helped it grow so much I became a member of the staff that helps to introduce PEG access and 'Olelo to the rest of the communities, that helps to train new clients on what PEG access is, how 'Olelo plays a vital role in Oahu's PEG access, and how they as concerned citizens and individuals of the community can also play a great role in instigating positive change in our community.

At Ark of Safety and as a faith-based non-profit we did not have a lot of money to purchase equipment to film or to edit our programs that we filmed, much less to pay for airtime of our programs. We knew that what we offered to our community members was life changing and could assist them in their day to day struggles, too, if they but knew about us. PEG access, namely 'Olelo, helped us to accomplish this. By having a convenient location in our community with cutting edge equipment and creative software, as well as the knowledgeable staff and willing assistance from others we were able to get our voice heard by our community members. What was even better was that by using our PEG access provider and the resources they put aside for us, we are able to consistently help those in our community in their daily lives.

We were able to help because we had a center for public access in our community, and 'Olelo made that possible. The people they employ are from the community so it helps to not only provide jobs, but also helps 'Olelo to truly know what the community needs are, what issues are important to the citizens and how they ('Olelo) can be of assistance to the community and not a hindrance. I love the fact that 'Olelo strives to provide not just physical and monetary means to provide access, but also emotional support and

encouragement, too. There is no real way to measure that tangibly as aloha is an intangible item; however, the results speak for themselves when you see youth who are stained by the stigma that mainstream media paints them with stand up and speak before you about themselves, their families, and the struggles they have endured and where they have come from. Most impressive of all is to see the results and hear the pride of accomplishment in their voices when they tell you about where they are at now and how they came to be here.

We see youth formerly cowed by the ugly reality of life and angry at everyone around them for the injustice they perceive done them, finally pull back their shoulders and say I now know who I am, and although I may not know exactly what I want to do I do know that I can make a difference in whatever I pursue if I just educate myself, ask questions and speak up for what I believe strongly about, and participate in the processes that make decisions about our futures. In fact some of you may know some of these youth I describe as many of them have interviewed you for Capitol Commentary. They see in you something they believe in and admire. Do not do what so many have done before and ignore their voices and discount their concerns and requests, but instead take into account the time, effort and passion they have invested in this whole process, and support SB 1789.

PEG access is not only about existing in a building and having the people come to you, but it is about residing in the community, and participating in all the events that happen within that community. It is about being part of a family that comes together when the community needs you and about just listening when they need to cry out; it is about being part of solutions and not part of problems; it is about being available and accessible to those who need you; and most of all it is about the multi-generations of people that make up that community.

It is about the kupuna who realize they are not pushed aside, but are eagerly sought for their experience and knowledge of the past, and how that can be applied to our present and the future. It is about seeing young children realize that they have options and choices for a better future than what their families have now if they only put forth their own efforts and combine with those who work with and for them, too. Their voices make a difference especially when called out in harmony with others around them. It is about families recognizing they want more and better for their children and supporting the good things and programs in our communities to help them achieve this goal. And it is about bridging the gap between generations so that there is cohesive harmony and intermingling with shared stories, opinions, ideas and suggestions that can only help to better the chances of our younger generations taking responsibility and initiative to improve the lives of our people as a whole.

We take joy in the fact that the aloha poured into them, although it cannot be quantitatively measured, we can see results in their improved grades, improved attendance, improved family relations, improved relationships with others, whether peers or those in authority over them. Where before these youth would resent, balk at and resist authority they now try to work along with authority to help set examples for others. and to make good and lasting changes in their own surroundings.

Changes like these do not come about because an organization or individual was mandated and ordered to do it. Changes like these come about because people see the need and are moved by love and compassion to make a difference in the lives of those around them. This cannot be written into any RFP, or put out for bid. Who can guarantee that the best bid would be best for the people who a PEG access provider is supposed to serve? The only way to guarantee that successes like this continue and are implemented in other communities is to support SB 1789, which will exempt PEG access from the procurement process, and also I ask that the Director continue to designate 'Olelo Community Television as the PEG access provider for Oahu. So, please, heed the voices of the people and vote in support of SB 1789.

In Support—with amendment request

This bill clarifies that procurement of services to provide public access television services is not the same as the state buying goods and services. As in the past, contracts shall be exempt from the requirements of Chapter 103D.

This continued exemption will ensure that services are not disrupted every three years or so by the procurement process, and recognizes that the funds which the cable companies are required to pay for public access channels and services are not the same as other public funds. They don't come from the state treasury and aren't used to purchase goods or services the way tax money is spent.

Television broadcasting and citizen journalism is evolving and cannot be reinvented every contract cycle. Just the time, effort and expense necessary to win competitive bidding and the dumbing down of the service offering in order to be lowest bidder is destructive.

Amendment request

I would request, however, that this Committee take the opportunity to revise the section of the bill relating to the cable advisory committee to make it more representative of the community served. There is a model in that the PUC contract with the telephone relay service for the deaf created an advisory committee consisting of users of the service rather than governor appointees. While the committee is advisory in any case, letting **users** provide the advice will help the service remain more responsive to their needs than having the governor appoint committee members who may reflect a particular political agenda or platform.

Again, the idea is to help nurture and grow public access television and make it independent of political pressure as much as possible.

These are **the people's television channels**, they shouldn't be subjected either to commercial or religious pressure through bidding or to political pressure through the advisory committee.

Thank you for the opportunity to submit testimony on S.B. 1773 SD1.

The Office of Information Practices ("OIP") opposes that portion of the bill that seeks to amend the definition sections under the public records law, chapter 92, HRS, the Uniform Information Practices Act (Modified) (the "UIPA"), and the open meetings law, part I of chapter 92, HRS (the "Sunshine Law"). OIP also offers comment on the proposed language for amendment to chapter 103 and 103D, HRS.

First, OIP strongly opposes amendment of the definitions sections of the Sunshine Law and UIPA. OIP uniformly opposes amendments that seek to insert board or agency specific or record specific provisions into these statutes purposely worded in terms of broad application. Moreover, the amendment here is both confusing and unnecessary to effectuate the intent of the bill to subject advisory groups making recommendations or decisions regarding purchases in excess of \$100,000 to the Sunshine Law and UIPA. Thus, if the legislature desires to make these advisory groups subject to the statutes, OIP strongly recommends that this be accomplished only through amendment to chapters 103 and 103D.

With respect to the UIPA, the bill seeks, at section 5, to amend the definition of "agency" under section 92F-3 of the UIPA to include the following:

The term "agency" includes, as appropriate, an advisory committee, advisory board, advisory commission, or similar group formed or convened by a governmental body, as defined in section 103D-104, for the purpose of making recommendations for the procurement, or making the decision to procure, goods, services, public works, or construction, in an amount in excess of \$100,000; provided that review committees established pursuant to section 103D-304 shall not be subject to this definition.

This proposed language is redundant given (1) the proposed amendments to chapters 103 and 103D; and (2) the fact that section 103D-105 already expressly makes the UIPA applicable to procurement records, reading in relevant part: "Government records relating to procurement shall be available to the public as provided in chapter 92F."

With respect to the Sunshine law, the bill seeks, at section 4, to amend the definition of "board" under section 92-2 of the Sunshine Law to include the following:

The term "board" also includes, as appropriate, an advisory committee, advisory board, advisory commission, or similar group formed or convened by a governmental body, as defined in section 103D-104, for the purpose of making recommendations for the procurement, or making the decision to procure, goods, services, public works, or construction, in an amount in excess of \$100,000; provided that review committees established pursuant to section 103D-304 shall not be subject to this definition.

Similarly, this proposed amendment is redundant given the proposed amendments to Chapter 103 and 103D.


With respect to the proposed language to sections in chapters 103 and 103D, at sections 1 and 2 of the bill, OIP believes that the proposed amendment, as drafted, is confusing and may have an unintended consequence. First, OIP suggests

that if the intent of the initial clause is to describe Sunshine Law boards, it should simply read "A board as defined in section 92-2." The other entities named would fall within the definition of "board," but are themselves not defined in section 92-2. Second, it is unclear whether the language "formed or convened by a governmental body" is meant to expand the covered groups to include Sunshine Law boards "or an advisory committee, board, commission, or similar group" formed or convened by a governmental body. Third, the language as drafted could be read to include more informal or internal groups, such as agency staff members or interagency government employees assembled to come up with an informal recommendation.

In summary, OIP strongly objects to any amendment of the UIPA or Sunshine Law definitions sections because it is unwarranted and unnecessary to accomplish the intent of this bill. OIP also suggests that the definition of covered groups in the proposed amendment to the procurement code be more carefully worded to provide better direction as to the entities sought to be covered and to avoid any unintended consequences.

Dear members of the Committee On Tourism and Government Operations,

I support PEG Access being made exempt from being put out to bid or perhaps more unfortunately; put out to pasture on a well manicured lawn.

With respect to the DCCA being confirmed as the only group to decide who will be the guardian of this public resource, It could be considered very risky and and not inclusive of the vast array of alternatives out there, particularly when considering our situation. Considering also, power seems to be concentrated in the hands of soo few, in addition to some behind the structure; the people who seem to exercise and say they have the power, although not having the active power since there are many more who would carefully want to work with one another and do what seems right to do. It seems wise to spread the power through such devices, representative or similar to the directly democratic type when it comes to matters of which we are discussing now. Seemingly primary among the methods of representative or directly democratic ways of organization are freespeech and access to a public resource. For one, without a continuing expression of freespeech and access to to a resource which in part conveys information in a diverse amount of ways, all people are marginalized in the many areas of society. Secondly, without this one form of expression and source of information being seriously protected by the government, once more in an representative or directly democratic way, we would be very hard pressed.

One manner taken by which we could decide who would be the management for PEG as well as it's management in itself, might be exemplified by a board voted in by the people whose mission will be to choose the PEG Access structure as well as manage it or a direct style of democracy which would take the form of the people deciding how to manage it and it's structure directly. Both may have a firewall in between outreach facilitation and programming and the management of PEG. An working example might be taken from the board of one of the Pacifica stations perhaps in California.

Once again, by submitting it to a bidding process we could have less this one form of expression or a greatly compromised one.. It is a strategic beach access we should not give up. I would further argue without a better informed populace we will not have the pressure to make wise democratic decisions be it voter owned elections or even definitely a Con Con.

The following are fowarded copies of testimonies given to the DCCA and the SPO (working with the DCCA in this other instance with the accepting commments for the draft RFP) respectively.

The first is from my comments to DCCA relating to the proposal of applying state procurement law as a process to PEG access initially as a first step, in the form of an RFP. THe second is excerpted from testimony given to both the SPO and DCCA concerning a proposed RFP for PEG Access as put out by the SPO and DCCA. In both I state PEG Access should not undergo the bidding process which would aggregiously put a public resource out for-bid. In both I also state such responsibilities of choosing who would be a caretaker for this public resource, as I did previously above, should be placed on the shoulders of many not just one department, essentially the executive branch. Further, in the second testimony stating ideally how the board of the PEG Access should be voted in from and by the public directly. With these structures should be concrete decsriptions of what are the responsibilities of PEG Access to enable the delineations.

To DCCA Director Mark Restervald

groups which represent the public interest directly involved at Olelo. Perhaps more strategically though Enviornmentalists, Community Activists as well as those who promote an informed citizency are essential.

This proposal is about something entirely different though It maybe like for all we know like apenning up a Constitutional Convention without direct democratic support.

In this current atmosphere of widespread attacks or our rights, our foundations, in effect our wholesale realities. It would be somewhat foolish and not at all strategie to change some of those fundamental rights and sonstructs which support those rights at this time.

Monopolistic juggernaughts as well as other misguided interests would be greatly represented even if none were on the board. It ith the deck stacked and the barbarians at the gate we may end up with something good on paper but, in reality well serve more the short term anarchistic interests in effect today. Akaku was assolted largely by a push from misquided developers. Our systen also in its twen maybe bought out by itestegically placed power brakers perhaps even those very same developers. Our public airwaves in the form of Broadcast Television and Eable, in well placed here allowing many to access it as their main source of information. Community Access as part of that communication network is able to help the community when used well and in a diverse

way. How can see this on many shows on Publis access. a summyly continually increasing number among the Public are turning to Cable access for information. if only because of a lack of information from the Commercial Broadcasters, (other media included). T.V. Broadcasters here give about I minute of soverage on an issue with a strange slant to boat. In contrast Olelo gives great roverage from many critical big picture angles, averaging much more in time as you well know. I get most of my information personally from Olelo and use it in video tape form to express an apinion to others on. Many of know do the same, especially with the Rublic portion as their source.

Tooking at the took of our democracy from books to radio to T.V. to the internet, each one may have been said to have replaced the former at one time or another (sometimes by a vested interest). What is old his been teld, what is new is due. However es time goes on we find each of these still are critical tools we use to build our democracy, when the goal is an informed citizenry. To heavily emphasize and depend upon a few tools like say as provided by the internet It would be like sending a child into the stacks of the New York City Tibrary and expecting him to get an comprehensive education.

When you look at many of the percured power atrustures out there, some of them are random, untisted and tyrannical. We should not let them change our structure in that way.

From time to time we have to make decisions which will affect us for generations to come. It seems however these decisions come every other week....

Community Access as a hub of information across the spectrum of our societal reality, broadcasts these harried moments not to hasten the problem but to hasten the solution. It maybe the case this is so, perhaps in part because we intend to do well. As with many things we do not mean to cause a problem only a solution to a circumstance, a necessity, as it were. We're all on the same side.

These fundamentally key issues such as PEG, is, must have greater priority paid to them and seeing as we are a community more help with drafting of them. This RFP by which we will base the guidelines for Community Access Television must have more assistance from others in our society. 2 departments nor one branch of government should decide on such weighty issues. Freedom of expression is one of these, use of a public resource as varied as this one is another. It seems prudent to have as a job for what checks and balence's we have left, the pretense of democracy, albeit one without habeas corpus.

With an eye towards the solution it seems far from difficult to see the branches of government weighed low from these issues. And again, to require 2 departments in the Executive Branch to take on these questions is very obviously not in the true spirit of the law which manages this Public Resource. The SPO and the DCCA can remark on aspects but of the entirety, help should be given yes, in it's entirety. It is one which should be taken on by the people directly.

What is at stake is a grassroots diverse and wild, an unending place where possibilities live. Truely something by which through experience we could live by and create the art of the possible. Without soo careful attentiveness as we had given in the creation of our media, the public portion, we may realize a well manicured lawn is our great defender against the Barbarians at the gate.

Shoulder this great weight upon the public directly and you will find we will move not only mountains but men.

To let this document dam itself would be easy, it will fail. But every finger, every hand can help towards a positive change. So in the tradition of a PEG I'll stick my finger into what there is left. I'll leave the invisible hand to you.

Overall there should be a firewall between PEG and the government, person, persons, private interests, companies, organizations, or parts of PEG Access itself, especially if it affects content from outreach to facilitation to programming. Funding, being able to pull the contract and importantly conflict of interest clauses should have a firewall between the government PEG. This is very much so, as not to allow pressure by use of them to alter it's management as interpreted under the Federal Law and the State Law, especially if it affects content from outreach to facilitation to programming.
