SUBJECT: SB 2051 - RELATING TO HEALTH

The position and views expressed in this testimony do not represent nor reflect the position and views of the Department of Health (DOH).

The State Council on Developmental Disabilities **SUPPORTS SB 2051**. The purpose of the bill is to appropriate funds for hearing and vision screening for newborns, pre-kindergartners, and children in school grades 3, 5, 8, and 11.

The Council believes that childhood screening, and identification and intervention for developmental delays during the early stages of development are crucial to ensuring that children are able to function in school to the best of their ability and to succeed. The Council further believes that expanding this to teenagers in grades 8 and 11 can lead to the identification and treatment that can alleviate problems that had previously gone undetected and to prevent future problems as a result of impaired vision or hearing.

We offer two suggestions regarding the bill for your consideration:

1) Amend the bill on page 2, lines 10-11, to delete reference to the specific age groups to allow DOH the flexibility to determine which age groups to provide screening for vision and hearing. DOH, through their previous vision and hearing screening program and Screening Task Force, should have data to support what age groups would be most appropriate for screening.

The language proposed is: "the implementation of a hearing and vision screening program for school aged children as established by Section 321-101, Hawaii Revised Statutes."



2) Reinstate the budget for DOH to continue the School Hearing and Vision and Follow Up Program that was terminated in 1995 due to budget restrictions. We defer to DOH for the budget requirements to implement the program.

The Council was a member of and participated on the Screening Task Force, established pursuant to SCR 70 HD1, SLH 2006. The purpose of the task force was to determine a means for a child to be screened prior to the start of the child's education, at the child's first entry into preschool and elementary school; to provide for diagnosis, referral, correction or treatment; and to integrate efforts of community and State organizations related to screening under this Hawaii childhood screening initiative. The task force completed and submitted a report to the Legislature prior to the start of the 2008 legislative session that summarized the efforts of the members and State and community partners to improve screening efforts.

We applaud the Legislature's initiative to address the value and importance of childhood screening and early identification and intervention for developmental delays. Thank you for the opportunity to submit testimony in support of SB 2051.

Aloha, Chair Suzanne Chun-Oakland, Vice-Chair Les Ihara, Members and Friends:

My name is Francine Kenyon. I am a long-time advocate and volunteer consultant for deaf, hard of hearing, and deaf-blind people of the State of Hawaii, and I wear many hats.

I support SB 2051, RELATING TO HEALTH that appropriates funds for hearing and vision screening for newborns, children, and teenagers. Screening is important as an early intervention tool to will help prepare the parents provide better for education for their children with hearing or/and vision loss.

My mother contracted German measles after the 23<sup>rd</sup> week of her pregnancy. No social worker met with her to discuss the possibility of having a child with disability. Mom was worried and did not know what to expect. The doctor checked me and found nothing wrong with me. At first Mom was happy that I was normal and healthy, but a year later when she accidentally dropped the pots and pans and noticed that I didn't react. She suspected something was wrong so she dropped the pots and pans again. I didn't move at all so Mom knew that I was deaf. She took me to the doctor who verified my condition. Mom spent years searching for a better education and better lifestyle for me. My parents provided home schooling, and I began to read the books at the age of 4. Like my mother, many parents are not prepared to raise newborns with disabilities. It would be helpful to have early intervention to screen for hearing and vision screening problems in children and teenagers to ensure they receive better education and training.

I strongly urge you to pass this bill to ensure early intervention to assist parents plan for better education for newborns, children and teenagers who have hearing and vision problems.

Mahalo nui loa for allowing me to testify on this important bill.
