TESTIMONY TO THE SENATE COMMITTEE ON HUMAN SERVICES AND PUBLIC HOUSING

Senate Bill 2053 - Relating to Services for the Disabled

The Disability and Communication Access Board (DCAB) opposes of Senate Bill 2053 relating to services for the disabled that makes an appropriation and establishes an Internet Access for the Disabled Program to offer free Internet access to individuals who are disabled as a responsibility within the Disability and Communication Access Board (DCAB).

While we recognize that this bill arose from the work of the Deaf-Blind Task Force, this bill does not represent the entire Task Force and the Task Force did not endorse this bill. Providing free Internet access to approximately one in five individuals with disabilities (20% of the population) would impact an estimated 250,000 people. Individuals with disabilities cover a wide financial spectrum of employed, underemployed, and unemployed people similar to the general population. It is unclear whether the intent of this bill is to pay the monthly charge in individuals' homes or to set up physical locations where individuals can go to obtain free access to the Internet. As such, we have no idea of the cost implications.

We urge you to hold this bill in committee.
