Please register my opposition to SB No 2091 on the ground that it is unrealistic as well as unenforceable.

To wit: A boardsailor who has lost his rig in a wave - quite a common occurrence - is now a swimmer. This bill would prohibit other boardsailors to come to his or her aid such as checking for injuries or offering a tow to shore.

Furthermore: On sailable days the conditions for swimmers and/or surfers are mostly not very favorable. In my 28 years of sailing the North shore launching at Kanaha beach park I have seldom seen any swimmers around my launching area at Kanaha beach park and never in the break area. I have encountered an occasional surfer or paddle boarder and the occasional jet ski and I have never witnessed or heard of any close encounters - let alone collisions - between swimmers and surfers and sail boarders.

Missing from this bill is a statistics of actual or near collisions between sail boarders, swimmers or surfers - taken from accident/incident reports over several

years, a fact that should give pause to the legislature before acting upon such an unrealistic and potentially economically destructive measure. A considerable number of visitors come to Maui specifically for its excellent sailing conditions. They will chose other locations if they are faced with arbitrary and unrealistic restrictions.

Finally the author of this bill should consider how this rule would be enforced. How many police officers on water craft would it take on an average sail day to patrol the sailing areas of the North Shore - just from Ho'okipa to Lower Kanaha to observe hundreds of sail boarders in the water - many of them in up to mast high + waves - wind blowing at 35 + mph?? If there are any swimmers out there - "endangered" by high speed sail boarders how would they spot them and ensure a measured 200 yard "safety zone". How could they tell a "swimmer" from a sailor who lost his rig?

Surely the community would be served better if our public parks were better patrolled to eliminate drug and alcohol use and dogs running around unleashed and unattended.

In comparison to the deplorable security situation in many of our parks the ocean is a very safe place!

To Whom it may concern,

On behalf of myself and many windsurfers who responsibly frequent the waters of the Hawaiian Islands, I would like request your opposition to this bill as proposed.

While ensuring the safety of all water users in Hawaii is an important issue, the incidence of damage resulting from unprovoked accidental collision between surfers/swimmers and windsurfers/kiteboarders is minimal.

Further, this bill (as proposed) will be exceptionally difficult to enforce or police in a practical and balanced manner.

Rather, by enacting this bill, the Senate provides a imbalanced and unfair opportuny for surfers or swimmers to create frictional conditions with windsurfers/kiters wishing to enjoy shared or nearby access. Rather than ensuring a balanced and safe level of access for all water users, this bill as proposed will (in practice) significantly allow a single surfer or swimmer to (legally) disrupt the otherwise harmless quiet enjoyment and shared access rights of the windsurfers or kiters in Hawaiian waters.

This bill would greatly affect in a negative way a very active windsurfing community that has a significant economic impact on the state of Hawaii.

This impact is not only in the form of tourism, but also in the form of businesses that have established Hawaii as a focal point of research and

development, training, retail, rental, and image capturing for the sport of windsurfing. All of these businesses help perpetuate Hawaii as a tourist destination to millions worldwide.

On behalf of the many windsurfers and kietrs who will be unfirly affected by the introduction of this bill, I ask you to vote against this bill.

Hawaii is world famous for water sports, in particular, surfing, windsurfing and kite-boarding. In addition to the many local residents and businesses benefiting from these activities, there are thousands upon thousands of people from all over the planer who visit the islands to experience the freedom the Hawaiian ocean offers. To restrict these sports may seriously damage the freedoms of choice and expression of this community.

My wife and I have enjoyed visiting the North Shore of Maui for many years and we have observed that windsurfers and kite-boarders generally focus there activity in areas where there is wind, whereas, wind tends to be counter-productive for both swimming and surfing. Therefore, wind conditions tend to act as a natural separator between these sports. As I understand it, on the North Shore of Maui windsurfers and kite-boarders are already prohibited from sailing before 11 am. This provides an exclusive time for swimmers, fishermen and surfers alike. Coincidentally, there is less wind before 11 am which tends to work out well for everyone. I windsurf and I surf and, in reality, there is very little difference between a threat to a swimmer from a surfer versus a windsurfer or a kite-boarder. I should know – I am a swimmer, a surfer and a windsurfer. To single-out two sports and impose restrictions upon them is contrary to the spirit of a shared ocean experience.

We live on a crowded planet and conflicts are ubiquitous in our lives. Snowboarding and skiing are dangerous to each other, but they manage to co-exist. Cars are dangerous to motorcycles, but they co-exist. The ocean and America represent freedom. The more we create restrictions, the more we live in an hyper-structured society where one freedom is favored over another and people begin to take less and less responsibility for their actions...they simply follow a million rules.

My name is Malcolm Cooper. I'm a swimmer and coach (coaching adults and children), organize ocean swim competitions, and also a windsurfer who lives on Maui - and I surf, too. In my professional life, I'm responsible for Pool and Ocean safety programs and lifeguards here on Maui. I'm writing to oppose the bill, SB 2091, making it illegal to have kiteboarders or windsurfers sail near a beach where swimmers are within 200 feet. I'm writing as a private citizen and ocean user.

From a legal perspective, there are already regulations and laws that Ocean Safety have to enforce safety at public beaches ... and specific to the conditions and safety of the beach on that day. They know the beaches, they know the conditions, the know the kinds of users, and they can use their professional judgement on a daily basis.

In addition, rather than going to the extremes in this bill, swimming areas can be set up, rules can be set up (eg; 10-man rule when surfers are on the water) that can adequately meet the needs of all ocean users and ensure safety of the public. There may be a law that could be written (or a regulatio between DLNR, Ocean Safety, and other appropriate agencies) to address this without the simplistic view of this bill.

From a practical perspective there are multiple points:

- * There are beaches, or beach areas, that can be set up to launch away from swimmers.
- * Who's to enforce when a stand-up surfer goes downwind through a normal surfing area.
- * When it's really windy, swimming far from shore is not typical ... launching and landing areas are all that need to be set up.
- * Windsurfing and Kiteboarding are a huge draw for our tourist industry on Maui ... and some parts of Oahu.

From a safety perspective, look at the number of injuries between kiteboarders and surfers, kiteboarders and windsurfers, windsurfers and swimmers, etc. The real danger and rescues occur from surfing (neck injuries in shore breaks, collisions in the shore break between surfers/body boarders and swimmers or each other, all sorts of body parts breaking in the surf on the reefs). If safety is the concern, logically it would be surfing that would be banned ... but that would be a ridiculous request ... almost as ridiculous as this bill.

We struggle here on some beaches between kiteboarders and surfers, sailboarders ... and we're finding that the judgement of the Ocean Safety Officers, DLNR, Harbor Commission, FAA, etc. in conjunction with Kiteboarding and Windsurfing associations are addressing the issues better. It's not perfect, but it is an effective work in progress that respects the rights and provides safety to all beach users.

Forgive the brevity of this letter, but I only heard about this bill a few minutes ago and had to get this off quickly or I'd elaborate and provide other examples and considerations.

This bill being proposed seems to be a veiled attempt by a non-windsurfer and non-kiteboarder (most likely a surfer or body boarder) to limit access to the ocean for a large segment of both residents and tourists alike.

For the past 25 years, I have used every single vacation without exception, to windsurf in locations all over the world. 8 years ago, my first visit to Maui proved that it is by far the best place in the world for recreational and competition windsurfing. My husband and I return every year to Maui even though there are other places much closer to us.

Since coming to Maui I have also improved my swimming and surfing skills, and of course have been aware of safety issues. My experience in Maui is that there is great respect for the ocean, the fish in it, and the people using it! I agree there may be a potential for injury when swimming and windsurfing is mixed along the shore, however I think the current situation works very well. Marked swimming areas that can be monitored by life guards, as well as the "do not sail before 11 am"
