Re: Senate Bill 2177, Relating to Public Land Liability

The City and County of Honolulu strongly supports Senate Bill 2177 which seeks to correct an inadvertent error in Act 82, Session Laws of Hawaii 2003.

The purpose of Act 82 (2003) was to establish a risk management procedure for improved public lands, involving the design and placement of signs that warn of dangerous natural conditions, and that affords the State and counties protection from liability for injuries resulting from those dangerous conditions. "Improved public lands" is defined to include all lands designated within the State and county park system, but excludes any public beach parks covered by the immunity provided by Act 190, Session Laws of Hawaii 1996. Act 82 provided the State and counties with immunity from dangerous natural conditions found on public lands while Act 190 provided immunity from liability arising from dangerous natural conditions in the oceans.

At the time of adoption of Act 82, it appears that there may have been an oversight or an assumption that land-based hazardous conditions do not exist in public beach parks, which explains the exclusion of "public beach parks" from the definition of "improved public lands." However, there are land-based hazards located within or abutting many of the City and County of Honolulu beach parks. Some of our beach parks abut mountain cliffs where there is a potential for falling boulders.

We believe that there was never an intent to exclude public beach parks from the coverage of Act 82. Therefore, we request your support in passing Senate Bill 2177 which is consistent with the underlying intent and scope of Act 82 to address dangerous natural conditions in all State and county public beach parks.
