Chair Rep. Shimabukuro and Members of the Human Services & Housing Committee.

The State Commission on Fatherhood (SCF) strongly supports SB2226 SD1 with an amendment changing "appropriated out of temporary assistance for needy families funds..." (p. 3, 1, 6-7) to "appropriated out of the general revenues of the State of Hawaii..." (from the original SB2226). The Department of Human Services (where SCF is place for administrative purposes) continues to declare that TANF funds cannot be used for staffing the State Commission on Fatherhood.

Appropriating \$150,000 (FY 2008-09) would support the State Commission on Fatherhood's implementation of its strategic plan by providing travel expenses of Neighbor Island Commissioners, establishing an office, and hiring a Director and a clerical staff person. These staff would support the Fatherhood Commission's efforts to implement its goals and objectives as described in SB2226 SD1.

The Legislature "in recognition of the important and unique role fathers play in the lives of their children, families, and communities..." established the State Commission on Fatherhood in 2003. Its mission is "to promote healthy family relationships between parents and children by emphasizing the important role fathers play in the lives of their children" (http://hawaii.gov/dhs/fatherhood/fatherhood/)

However, the State Commission on Fatherhood has received no State funding for staffing and consequently has functioned with no staff in the 5 years since it was established in 2003. During these same 5 years the State Commission on the Status of Women has received over \$500,000 for staffing its work. Although the State Commission on Fatherhood's mission is narrower than the State Commission on the Status of Women (which needs additional support for its important work), the Fatherhood Commission cannot effectively carry out its mission without staffing.

The State Commission on Fatherhood supports passage of SB2226 SD1 (with the above amendment).
