I am writing in support of SB 2583. I currently serve as President of the Friends of the Hawaii State Art Museum.

I believe there are four important reasons to enact this bill.

- 1. The potential economic and cultural benefit to the State of Hawaii. We have the ability to brand Hawaii as an art destination for visitors. They can learn from, enjoy and acquire world class art from artists of Hawaii. Many of our artists are collected by the finest museums in the United States. The Guggenheim Museum in New York, the Whitney Museum in New York, and the Yale University Art Gallery in New Haven, all have artists from Hawaii in their collections. The present size of our museum is not large enough to create a brand for the Hawaii artists community and to create another visitor industry. The state also owns many pieces now in storage that could easily be displayed in an expanded museum. The Hawaii art industry is vibrant and alive. The state has an opportunity to create a venue to take advantage of something that is already here and only needs to be exposed and branded to add another reason for tourists to come to Hawaii and learn about our culture and add to our economic base.
- 2. There is <u>nominal cost</u> to create this new visitor industry brand compared to creating the infrastructure for potential new industries. The state already owns all the real estate and art needed to create the expanded museum. Our 1% art law enables the state to acquire many more pieces than can be shown through the Art in Public Places program and the museum. In fact showing this art collection was the original basis for the Museum. Now we have the opportunity to show many more works in a building we already own and to move non-museum departments to another building we currently own.
- 3. The <u>educational value</u> of an expanded museum to the people of Hawaii and our visitors. A larger museum has the ability to tell the history and evolution of Hawaii through the eyes of our artists. They not only portray their views of our incredible natural beauty, but they tell the story of our changing society. An expanded museum would enable us to tell a more complete story to demonstrate our unique culture.
- 4. The <u>ability to keep our best and brightest</u> artists in the islands. With a branded art industry, our artists would not need to move to the mainland to support themselves in their chosen career. Our artists could pursue their creative talents while staying in Hawaii.
