- Department's Position: The Executive Office on Aging (EOA) has concerns regarding SB 2830
- 2 SD 2 HD1 as certain provisions in the bill would negatively impact the Executive supplemental
- 3 budget priorities.
- 4 **Fiscal Implications**: There is an unspecified amount of general funds to be appropriated to the
- 5 Senate and House of Representatives to contract with a qualified consultant to conduct a cash and
- 6 counseling project and to EOA to expand the KUPUNA CARE program and to continue its respite
- 7 inventory project with UH School of Social Work for State Fiscal Year 2008- 2009.
- 8 **Purpose and Justification**: Your Committees have amended this bill by inserting a new "PART
- 9 VI" to this measure to increase payments for the level of care for adult residential care homes
- types I and II, licensed developmental disabilities domiciliary homes, community care foster
- family homes, and certified adult foster homes by seven percent from \$641.90 to \$686.83 for level
- 12 I and from \$749.90 to \$802.39 for level II.
- SB 2830 SD 2 HD1 is the family caregiver omnibus bill which:

- Extends the Joint Legislative Committee on Family Caregiving; changes the committee's name to
- the Joint Legislative Committee on Aging in Place; expands the committee's mandate to include
- aging in place issues related to family caregiving; requires the Aging and Disability Resource
- 4 Center to report to the committee; requires the Joint Legislative Committee to develop a model for
- 5 a cash and counseling project; appropriates funds to the Joint Legislative Committee; allows
- 6 Kupuna Care to include overnight, weekend, and emergency respite, as well as provide grants to
- 7 caregivers and for home modification; appropriates funds to the Kupuna Care program; establishes
- a task force to focus on the needs and issues of grandparents raising grandchildren; appropriates
- 9 funds to the Executive Office on Aging to continue its respite inventory project in collaboration
- with the University of Hawaii.
- EOA appreciates this proposal. Through Act 204, SLH 2007, EOA had contracted with
- the University of Hawaii to coordinate family caregiver support services and policies statewide.
- We are pleased to have worked in partnership with the University, the Joint Legislative
- 14 Committee, and community stakeholders to have contributed to the research that was cited in this
- bill. Additionally, we will continue to work together to strengthen and expand KUPUNA CARE
- services to meet the needs of Hawaii's older adults and their family caregivers. It should be noted
- that Act 204, SLH 2007, already appropriated an additional \$525,000 to EOA for Kupuna Care
- services in fiscal year 2008-2009.

- 19 EOA would be pleased to continue working with the School of Social Work to expand the
- 20 current respite inventory as long as any appropriations do not negatively affect the Executive
- supplemental budget priorities. EOA also supports the establishment of a task force to focus on the
- 22 needs of and issues facing grandparents raising grandchildren. EOA is pleased to be named as a
- 23 member of the Task Force, and we will participate to our full extent.

Mr. Chairman, Vice Chairman, Members of the Committee.

I support SB 2830 with the name change "Aging in Place," although on page three Paragraph B. I would like to see under the definition of "family caregiver" a person age sixty or older be deleted.

Members of the disability community under the age of sixty, whose caregivers are providing for them, are being betrayed by being left out of the bill.

Last night on national television there was an article portraying a fourteen-year-old girl and her mother providing for her father who was fifty five years of age with dementia. This is only one of the hundreds of thousands or more providing for families or individuals within a family who are in need of constant care, and family caregivers are not available.

Many people today and many families are able to eat together, take walks, go to the movies and other events, and they take all these activities for granted. Yet there are diseases such as multiple sclerosis which continue to take its toll, and such families are not able to have this kind of family life. In these families, some family member must help their loved ones with a transfer from bed to wheelchair, showering, dressing, preparing meals, etc. MS is typically diagnosed in people aged between twenty and forty five years old. Are we going to leave caregivers for these people behind, which Senate bill 2830 presently does, or can we define family caregivers to include just that: family caregivers of all ages?

I hope you will address this oversight and amend SB2830 so that caregivers are not limited to people providing care only for those sixty or older.
