# TESTIMONY ON SENATE BILL NO. 3033 – RELATING TO PRICE GOUGING DURING EMERGENCIES.

Senate Bill No. 3033 seeks to amend Chapter 209 of the Hawaii Revised Statutes by clarifying that price increases on services, rentals, and construction or repair contracts during disasters are illegal.

Pursuant to Chapter 209 of the Hawaii Revised Statutes, once the Governor makes a formal declaration of a natural disaster, it is illegal to increase the selling price of any commodity in the area(s) impacted. This prohibition is limited in nature and only applies to commodities and residential landlord/tenant rentals. Since the definition of "commodity" currently does not include "rentals", or "construction or repair contracts", it appears that a disaster declaration would not prohibit an increase in prices in these areas. Consequently, if price gouging were to occur by service providers, such as tradesmen, who try to take advantage of a crisis by suddenly "jacking up" their hourly rate, the absence of specific regulatory authority will present difficulties in any subsequent prosecution against them for price gouging. The Department is in support of this amendment because it will correct this deficiency and will provide greater consumer protection to our citizens in the aftermath of a disaster.

Chair Kokubun, Chair Inouye and Members of the Joint Committees:

I am Tim Lyons, President of the Subcontractors Association of Hawaii. The Subcontractors Association of Hawaii represents the following nine separate and distinct associations that are listed below.

We are opposed to this bill.

We are not opposed to the bill because we think contractors should be allowed to gouge during emergencies. What we are concerned about are the terms of this bill with the language that charges and costs must be consistent with federal equipment and other rate schedules. Perhaps there are such rates or schedules but we are not familiar with what they are or how we access them. Additionally, (page 2) the bill specifies that any charge greater than 20% is presumed to be inconsistent.

The construction industry has faced a multitude of price increases recently. In fact, last year items such as insulation, asphalt based roofing paper, sheet metal and other items were going up 5% to 15% a week during certain times of the year. If contractors are limited to only charge 20% and that 20% represents a charge that is below their cost, the people that have suffered damages as a result of a disaster are not going to be able to get the goods and services that they need in order to bring their lives back to normal or perhaps in some cases, to abate an emergency situation.

We are not sure what the magic answer is, but we do know that this bill appears to "cap" the contractor's charges, possibly below what his costs are and in that event, we think it will be a disservice to the consumer.

Based on the above, we are not in support of this bill.
