Aloha Chairs Menor & Fukunaga, Vice-Chairs Hooser & Espero, & Members of the Committee:

My name is George White, a second year-law student at the University of Hawaii, and creator of stopstyrofoamhawaii.org. I am writing in strong support of SCR142/SR74, which urges our State Government to set the example and voluntarily utilize styrofoam alternative products in their procurement, contracting and day-to-day operations.

The resolutions before you represent the product of months of research, discussion and debate, and the beginning of a conversation here in Hawaii, that has been happening in municipalities and states across the Country, and around World, for the last two decades.

The harmful effects of one-time use styrofoam products is incontrovertible stretching from the petroleum it takes to produce it, the health issues it raises for the consumer, to the detrimental impact and threat it poses to Hawaii's environment and ecosystems.

There are readily available and affordable alternatives to styrofoam food-service products and businesses and vendors around the State are already engaged in efforts to be more environmentally conscious, offering Hawaii's consumers eco-friendly alternatives to styrofoam. It is incumbent upon this Legislature to encourage and promote these voluntary, community-driven campaigns that educate and inform both businesses and the public, and transform consumer habits and lifestyle.

SCR146/SR78 is definitely a step in the right direction toward a more environmentally-conscious and sustainable Hawaii. Attached to this testimony, is a petition signed by 440 individuals, in a span of just 40 hours, urging this Legislature to support and adopt the Resolutions before you today.

### Support of S.R. 78 and S.C.R. 146

My name is Kati Corlew, and I am a graduate student of Community Psychology at the University of Hawai'i at Manoa. I've been following several pieces of legislation this semester, including the bills and resolutions regarding the use of Styrofoam in Hawai'i. I've done a considerable amount of research and have spoken with a number of people on both sides of the debate. I do not speak for any group or organization, only for myself. I would like to present several of the conclusions that I have drawn regarding Hawai'i's future sustainability practices in relation to Styrofoam use.

#### **Regarding Immediate Effects of S.R. 78 and S.C.R. 146:**

- S.R. 78 and S.C.R. 146 allow businesses the encouragement and ability to be leaders to Hawai'i's sustainability efforts. The resolutions allow individual businesses to judge the response of their clientele while options remain open.
- Businesses that choose to move in a more sustainable direction will receive positive publicity, and stand to gain customers as a result. Green products and Sustainable Practices are all the rage nowadays.
- As businesses move voluntarily to sustainable options, market demands will create more sustainable, more affordable, and more readily available options to Hawai'i businesses and consumers.
- Voluntary business compliance will serve to build both demand and availability of sustainable alternative products, thus building the market infrastructure necessary for long-term sustainability efforts.
- There is a concern that sustainable alternatives to Styrofoam are more expensive than polystyrene products. However, on a per customer basis, we're talking an extra 10 cents per plate lunch. My informal, very unscientific survey of friends and neighbors shows that people are willing to spend a dime toward sustainability. Again, this resolution allows for businesses to gauge their clientele response to guide their decision-making.

#### **Regarding Long-Term Sustainability Concerns for Hawai'i:**

- Recycling efforts within the community should be made **IN ADDITION TO** consumer shifts to sustainable products. This is not an Either/Or situation. **BOTH** practices must be utilized for Hawai'i's sustainable future.
- The debate on polystyrene should not be a Paper Vs. Plastic issue, since we know that both items are environmentally unfriendly, and both are ultimately

Chairs & Committee Members

Voluntary compliance is fine but we question the validity of your resolution.

In paragraph 1, polystyrene poses a threat to the general health and welfare of Hawaii's ecosystem and environment, but also the general health and welfare of Hawaii's citizens.

Polystyrene (Styrofoam) has been used for over 30 years. We have not heard of anyone getting sick or causing death. This resin is approved and controlled by the Federal Food and Drug Administration. In the earlier bills, benzene was illustrated as the carcinogen, but after written clearance from our resin manufacturers that benzene was not in our resin, we find these issues removed. We ask this committee to address this issue to the Federal Food and Drug Administration.

The land fill issue should not become a problem, as there are alternatives to dispose of Styrofoam, either by H Power, (waste to energy), recycle back to resin or utilizing new technology from Japan, converting plastic to oil.

In paragraph 5, it states that polystyrene creates a dense black irritating smoke at H Power. We extrude polystyrene resin in our plant at 425° degree temperatures and there is no dense black irritating smoke containing acidic gases and over ninety different chemicals, including carbon monoxide and the known neurotoxin and possible carcinogen styrene. We have air quality inspectors monitor the air quality in our plant and our air quality is fine.

Finally, polystyrene should be treated the same as aluminum cans, glass bottles, plastic bottles. Polystyrene has many alternative uses, such as waste to energy, recycle back to resin or recycle plastics back to oil.

Whether it is released into the air and water during manufacturing, by ingesting it when eating from styrofoam, or when it leaches into our air and water supply after disposal, styrofoam and all the chemicals that go with it are getting into our bodies at an alarming rate, leading to a host of ailments from Chronic Fatigue Syndrome to various forms of Cancer to malformation of reproductive organs in boys (directly linked to the estrogenic quality). Also, have you ever volunteered in a National Park? Picking up rubbish in such a sacred place is heart wrenching and with all the winds blowing on these islands, rubbish can get everywhere. If it is going to collect on the side of the parking lot at Haleakala, let's at least make sure it is biodegradable. One of the biggest complaints from people who live in Hawaii is that we are ignored (politically) by the mainland. What a great way to stand up and say to the rest of the country "We are about more than just your vacation". We are carrying on the traditions and the ideals of the Hawaiian people by embracing both human and habitat sustainability. We aim to be an example to the country and the world of what can be done to preserve our habitat. Add that to the Smoke Free by 2010 campaign, the "green" architecture of many government buildings, such as UH, and the sustainable development of Olowalu, Maui, and we have quite a lot to brag about!
