I have just completed my fifth year of teaching in the Shidler College of Business at the University of Hawai'i-Manoa, and have been fortunate enough to be allowed to create my own classes in Sports and Entertainment Management, Legal Issues in Sports and Entertainment, and Sports and Entertainment Marketing. The interest in these classes has been overwhelming by the students, validating my belief that Hawai'i can, and should be the epicenter for the growth and economic development of this exciting industry, "The Sports and Entertainment Industry". It is because of my belief that there should be a degree granting program in Sports and Entertainment Management at the University of Hawai'i, that I am testifying in favor of SCR 70.

Sports and Entertainment is a multi-billion dollar business, and the need for students having skills that would allow them to manage or to administrate is in high demand. The State of Hawai'i would be well served by promoting a curriculum in Sports and Entertainment Management, located at the University of Hawai'i, to recruit students from around the world, as well as our own local students, to become future leaders in the arena of sports and entertainment. I have found my students to be eager learners, and they have expressed interest in pursuing a career in sports and entertainment, but the dilemma is that they want to stay on the island, and don't feel that there are any opportunities here for them.

The major objectives of establishing a degree program for Sports and Entertainment Management would be:

- To recruit, and educate students about the business of sports and entertainment,
- To develop a curriculum that integrates international dimensions,
- To offer international internship programs for students and faculty,
- To provide a national resource to other educational institutions for teaching international business techniques and methodologies dealing with the sports and entertainment industry,
- To sponsor research projects aimed at increasing the international competitiveness
 of American businesses engaged in global competition or research focused on
 those firms interested in gaining entry into international markets,
- To provide practical answers to management challenges associated with international competition,
- To offer conferences on current international, political, and economic events, business skills development, and expertise that is vital to successful involvement in international markets,
- To advocate for additional sports facilities, and to maximize the use of athletic and event venues for government, professional, amateur, and collegiate sports organizations,
- To attract major sports and special events to Hawai'i that will provide internship programs, better paying jobs, positive media exposure, and enhance the economic vitality of our region,
- To support collegiate and high school athletic teams, event promoters, and amateur athletic associations in their development,
- To prepare university students with global awareness and the sensitivity to cultural and international business skills expected by firms engaged in the global marketplace.

In order to make this vision a reality there will need to be people willing to champion the cause. The concept is apolitical, and it is win-win for everyone. We need to keep our students in Hawai'i, to prepare them for a future in the fastest growing and most dynamic industry in the world, and we need to become the global leader in the advancement of this industry, which will in turn add to the economic development of our wonderful State. Can we make this a reality? My students hope so!
