Dear Madam President:

Transmitted herewith are proposed changes to the FB 2009-11 Executive Budget (House Bill No. 200) to:

1. Reflect federal stimulus funds under the American Recovery and Reinvestment Act of 2009 (ARRA).
2. Correspondingly reduce general fund appropriations to certain programs that receive offsetting federal funding under the ARRA to address the State's budget shortfall.
3. Appropriate additional federal TANF funds that Hawaii recently qualified for. This is necessary because appropriation of the TANF funding is a federal requirement.

A draft of an immediate passage appropriation bill will be sent under separate cover to request the necessary ARRA, general fund, TANF and other adjustments for FY 2008-09.

Please note that these requests reflect the amounts of the ARRA stimulus funds that are known at this time. For competitive grants, or where amounts are still uncertain, departments will request my approval to increase federal fund expenditure ceilings in a manner comparable to current procedures for non-appropriated federal funds.

Your favorable consideration is requested for the attached budget items:

Operating:

Department of Accounting and General Services:

Create V fund ceiling of \$292,900 in FY 10 for the State Foundation on Culture and the Arts (AGS 881/LA) to provide grants to non-profit organizations to preserve or reinstate culture and the arts employment positions.

Department of the Attorney General:

1. Create V fund ceiling of \$2,880,629 in FY 10 and \$2,864,318 in FY 11 for the Justice Assistance program (ATG 100/AC) to reflect higher allocations for Byrne/JAG, VAWA, and VOCA grants.
2. Increase the trust fund ceiling by \$2,119,186 in FY 10 and \$258,149 in FY 11, and create V fund ceiling of \$4,113,713 in FY 10 and \$501,112 in FY 11 for the Child Support Enforcement Agency (ATG 500/GA) to meet the matching requirement for federal stimulus funds.

Department of Business, Economic Development and Tourism:

1. Add 3.00 temporary positions and create V fund ceiling of \$5,784,300 in FY 10, and add 2.00 temporary positions and create V fund ceiling of \$202,400 in FY 11 in the Strategic Industries (BED 120/SI) program for the Energy Efficiency and Conservation Block Grant program. The funds will provide grants to the State and counties to assist in implementing strategies to reduce fossil fuel emissions, reduce total energy use, and improve energy efficiency in the transportation sector, building sector, and other appropriate sectors.
2. Add 9.00 temporary positions and create V fund ceiling of \$23,979,400 in FY 10, and add 5.00 temporary positions and create V fund ceiling of \$506,000 in FY 11 in the Strategic Industries (BED 120/SI) program for the State Energy program. The funds will provide grants to the State to increase energy efficiency to: reduce energy costs and consumption for consumers, businesses, and government; reduce reliance on imported energy; improve the reliability of electricity and fuel supply and the delivery of energy services; and reduce the impact of energy production and use on the environment.
3. Create V fund ceiling of \$14,485,565 to provide sub-awards to finance the construction or acquisition and rehabilitation of qualified low-income rental housing projects under the Low Income Housing Grant.
4. Create V fund ceiling of \$6,574,400 in FY 10 and \$3,287,210 in FY 11 for gap funding for the production of stalled affordable rental housing projects under the Tax Credit Assistance Program Grant.

Department of Education:

1. Create V fund ceiling of \$9,200,000 in FY 10 and \$13,100,000 in FY 11 for the Weighted Student Formula program (EDN 100/AB) to reflect State Fiscal Stabilization Funds, and decrease general funds by the same amount to help address the State's budget shortfall.
2. Create V fund ceiling of \$19,796,559 in FY 10 for the No Child Left Behind program (EDN 100/DB) to reflect additional Title I grants to Local Educational Agencies (\$16,587,184) and Educational Technology State Grants (\$3,209,375).
3. Create V fund ceiling of \$20,493,170 in FY 10 for the Special Education for the Disabled program (EDN 150/NB) to reflect additional IDEA Part B Grants to States (\$19,962,635) and IDEA Part B Preschool Grants (\$530,535).
4. Increase the revolving fund ceiling by \$189,284 in FY 10 and \$65,067 in FY 11 for the Special Education – Other Related Services program (EDN 150/YK) to reflect additional stimulus Federal Medical Assistance Percentage (FMAP) funds from the Department of Human Services (DHS), and decrease general funds by the same amount to help address the State's budget shortfall.
5. Create V fund ceiling of \$116,000 in FY 10 for the School Community Based Management program (EDN 200/GQ) to reflect additional McKinney-Vento Homeless Assistance Act funds.

Office of the Governor:

Create V fund ceiling of \$35,000,000 in FY 10 to provide additional support for education programs, from K through 12 and higher education.

Department of Health:

1. Increase stimulus FMAP funds coming through DHS (\$20.0 M in FY 10 and \$6.9 M in FY 11) and decrease general funds by the same amounts for the Adult Mental Health Division - Outpatient program (HTH 420), the Child and Adolescent Mental Health Division (HTH 460), and the Developmental Disabilities (DD) program (HTH 501). The additional FMAP funds are due to increasing the percentage under the ARRA and are reimbursements through the DHS. For the Adult and CAMHD programs, special fund ceiling adjustments are being made to reflect the FMAP funds coming through DHS; for DD, a corresponding interdepartmental transfer fund ceiling adjustment is made for the FMAP funds coming through DHS.
2. Create V fund ceiling (six temporary positions and \$508,271 in FY 10 and \$484,271 in FY 11) for the Disability and Communication Access Board to reflect Medicaid Title XIX stimulus funds.

3. Create V fund ceiling (\$2.1 M for FY 10 only) for the Family Health Services Division-Early Intervention (HTH 560) program to reflect stimulus funds under Part C of the IDEA. The funds will be used to provide early intervention services and support.
4. Create Emergency Medical Services and Injury Prevention (HTH 730) program V fund ceiling to reflect ARRA funds for building a mobile electronic health record exchange system (\$1.2 M for FY 10 only) and development of an EMS provider and Hospital Emergency Department Broadband Telecommunications system (\$9.8 M in FY 10 and \$7.9 M in FY 11).
5. Create V fund ceiling (\$0.6 M for FY 10 only) for the State Laboratories Division (HTH 710) to reflect ARRA funds relating to alternative energy, energy efficiency, and green jobs.
6. Increase the FY 10 ceilings for the Drinking Water Treatment Revolving Loan Fund (\$20 M revolving fund) and the Water Pollution Control Revolving Fund (\$29.9 M revolving fund and \$0.1 M federal fund ceiling) to provide loans and grants for the construction of drinking water infrastructure improvements and wastewater infrastructure improvements, respectively. Similar amounts will be appropriated as "V" funds for deposit into the revolving funds.
7. Create V fund ceiling (\$1.7 M for FY 10 only) for the Clean Air Branch to allow the branch to partner with government or non-profit organizations for various clean air projects.
8. Create V fund ceiling (\$1.5 M for FY 10 only) for the Solid and Hazardous Waste Branch for the Leaking Underground Storage Tank program to ensure underground storage tanks are promptly cleaned up and contained.
9. Create V fund ceiling (\$0.3 M for FY 10 only) for the Environmental Planning Office for Water Quality Management purposes.

Department of Health – Hawaii Health Systems Corporation:

Hawaii Health Systems Corporation: create V fund ceiling of \$22,500,000 in FY 10 and \$45,000,000 in FY 11 and increase the special fund ceiling by \$2,500,000 in FY 10 and \$5,000,000 in FY 11 to provide matching funds for the automation of medical records.

Department of Human Services:

1. Create V fund ceiling of \$500,000 in General Support for Child Care (HMS 302) to enhance the existing quality care contracts, including the infant and toddler scholarships, to comply with ARRA requirements.

2. Create V fund ceiling of \$2,600,000 in Cash Support for Child Care (HMS 305) for child care subsidies.
3. Create V fund ceiling of \$550,000 in General Support for Self-Sufficiency Services (HMS 903/FS) to provide administrative funds for the Supplemental Nutrition Assistance Program (SNAP) to implement changes mandated in the ARRA and help manage the rising SNAP caseload.
4. Create V fund ceiling of \$15,000,000 in General Support for Self-Sufficiency Services (HMS 903/FA) for increased expenditures in basic cash assistance and non-recurrent short-term benefits for Temporary Assistance for Needy Families (TANF) clients. TANF expenditures will be incurred by existing exit and retention bonus programs, by allowing for an increase in earned income deductions for certain families, and adding the employment subsidy program to the basic cash assistance programs.
5. Create V fund ceiling of \$10,000,000 in General Support for Self-Sufficiency Services (HMS 903/FE) for increased TANF expenditures for the subsidized employment program that qualifies for the temporary contingency fund established in ARRA.
6. Increase the federal fund ceiling by \$20,000,000 in General Support for Self-Sufficiency Services (HMS 903/FA) to enable DHS to receive and expend TANF contingency funds through the Deficit Reduction Act of 2005 (TANF authorization bill). Hawaii has met the "needy state" trigger for high food stamp caseloads. This request is not ARRA-related and is designated as an "N" fund ceiling increase because TANF funds need to be appropriated pursuant to federal requirements.
7. Create V fund ceiling of \$1,455,371 in FY 10 for Vocational Rehabilitation (HMS 802/GA) to reflect the increase in federal grant awards for vocational rehabilitation and independent living services programs.
8. Create V fund ceiling of \$2,300,000 in FY 10 and \$1,300,000 in FY 11 for Child Protective Services Payments (HMS 303/WP) to reflect the increase in federal Title IV-E funding due to the enhanced FMAP rate under ARRA. The funds will be used for additional foster care services.
9. Create V fund ceiling of \$151,997,757 in FY 10 and \$56,984,906 in FY 11 for Health Care Payments (HMS 401/PQ) to reflect the increase in federal Medicaid funds due to the enhanced FMAP rate under ARRA. Reduce general funds by \$131,760,951 in FY 10 and \$50,028,369 in FY 11 for Health Care Payments (HMS 401/PQ) to offset the increase in federal Medicaid funds allocated to the MedQUEST Division to help address the State's budget shortfall.

Department of Labor and Industrial Relations:

1. Create V fund ceiling of \$150,500,000 in FY 10 for the Unemployment Insurance program (LBR 171/LA) to pay for increased unemployment insurance benefit payments.
2. Create V fund ceiling of \$5,305,964 in FY 10 in the Office of Community Services (LBR 903/NA) for the Community Services Block Grant program to provide emergency services, jobs, education, and job training to low-income individuals.
3. Create V fund ceiling of \$4,041,461 in FY 10 in the Office of Community Services (LBR 903/NA) for the Weatherization Assistance program. The program is expected to reduce energy costs by installing energy saving devices in low-income households.
4. Create V fund ceiling of \$1,426,246 in FY 10 in the Workforce Development program (LBR 111/PA) for re-employment services for the unemployed and labor market information and assessment.
5. Create V fund ceiling of \$6,820,941 in FY 10 in the Workforce Development program (LBR 111/PB) for employment and training services to adults, dislocated workers, and older individuals.

Department of Transportation:

1. Create V fund ceiling of \$7,000,000 in FY 10 for the Maui Highways (TRN 531/DF) program for highways special maintenance projects.
2. Create V fund ceiling of \$6,000,000 in FY 10 for the Molokai Highways (TRN 541/DF) program for highways special maintenance projects.

University of Hawaii:

Create V fund ceiling of \$14,600,000 in FY 10 for University of Hawaii, Systemwide Support (UOH 900) to reflect incoming State Fiscal Stabilization Funds for higher education purposes and correspondingly reduce \$14,600,000 in general funds in FY 10 to help address the State's budget shortfall.

CIP:

Department of Transportation:

Add \$2,100,000 in revenue bond funds, \$6,000,000 in federal funds, and \$17,000,000 in V funds for plans and construction in FY 10 for Kuhio Highway Improvements, Hanamaulu to Kapaa, Kauai, for a new Kapaa Bypass and/or widen sections of Kuhio Highway.



To reflect the ARRA stimulus funds, Section 2 of House Bill No. 200 is amended to add in a new Means of Financing "V" to differentiate the federal stimulus funds from "regular" federal funds.

Lastly, various provisos are proposed to allow departments flexibility in the use of ARRA stimulus funds.

DEFINITIONS

Amend Part I, Section 2 as follows:

SECTION 2. DEFINITIONS. Unless otherwise clear from the context, as used in this Act:

- (a) "Program ID" means the unique identifier for the specific program, and consists of the abbreviation for the organization responsible for carrying out the program, followed by the organization number for the program.
- (b) "Expending agency" means the executive department, independent commission, bureau, office, board, or other establishment of the state government (other than the legislature, office of Hawaiian affairs, and judiciary), the political subdivisions of the state, or any quasi-public institution supported in whole or in part by state funds, which is authorized to expend specified appropriations made by this Act.

(c) "Means of financing" (or "MOF") means the source from which funds are appropriated or authorized to be expended for the programs and projects specified in this Act. All appropriations are followed by letter symbols. Such letter symbols, where used, shall have the following meanings:

- A general funds
- B special funds
- C general obligation bond fund
- D general obligation bond fund with debt service cost to be paid from special funds
- E revenue bond funds
- J federal aid interstate funds
- K federal aid primary funds
- L federal aid secondary funds
- M federal aid urban funds
- N other federal funds
- R private contributions
- S county funds
- T trust funds
- U interdepartmental transfers
- V federal stimulus funds
- W revolving funds
- X other funds

(d) "Position ceiling" means the maximum number of permanent positions that an expending agency is authorized for a particular program during a specified period or periods, as denoted by an asterisk.

(e) "Capital project number" means the official number of the capital project, as assigned by the responsible organization.

PROVISOS

Amend Part VII to add two new subsections to read:

SECTION _____. Provided that unless otherwise provided in this Act, the governor is authorized to transfer federal stimulus funds from the American Recovery and Reinvestment Act of 2009, appropriated for the office of the governor (GOV 100) for fiscal year 2009-2010, to EDN and UOH programs for the purpose of providing additional support for education programs, including elementary, secondary and higher education, when the need has been determined by the Governor.

SECTION _____. Provided that the governor may approve the expenditure of federal stimulus funds for operating and capital improvement purposes designated with the letter "V" which are in excess of levels authorized by the legislature provided further that the governor may allow for an increase in the federal stimulus fund authorization ceiling for the program to accommodate the expenditure of such funds.

By amending Section 52 to read as follows:

SECTION 52. The governor may approve the expenditure of federal funds designated with the letter "N" for operating and capital improvement purposes which are in excess of levels authorized by the legislature; provided further that the governor may allow for an increase in the federal fund authorization ceiling for the program to accommodate the expenditure of such funds.

By amending Section 76 to read as follows:

SECTION 76. Provided that no funds, including federal funds, shall be expended to fill any position not authorized by the legislature; provided further that this prohibition shall not apply to:

- (1) The University of Hawaii and the Hawaii health systems corporation;
- (2) Positions entirely federally funded;
- (3) Positions established pursuant to section 76-16(b) subsections (3), (12), (13), (21), and (23), Hawaii Revised Statutes; [ø]
- (4) Where an agency has explicit statutory authorization to establish positions to accomplish necessary functions; or
- (5) Temporary positions funded wholly or partially with federal funds from the American Recovery and Reinvestment Act of 2009;

provided further that with regard to any of the positions identified in paragraphs (1), (2), (3), [ø] (4), or (5), the respective agency or department shall submit a report to the legislature within ten days of each use of this provision; provided further that the report shall include:

- (1) Authority used to establish the position;
- (2) Date the position was established;
- (3) Projected date the position will be filled;
- (4) Amounts projected to be expended in fiscal year 2009-2010 and in fiscal year 2010-2011;
- (5) Source of funds used to pay for the position; and
- (6) Functions to be performed by the position.
