## A BILL FOR AN ACT

MAKING APPROPRIATIONS FOR COLLECTIVE BARGAINING COST ITEMS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. There are appropriated or authorized from the  
2 sources of funding indicated below to Program Planning,  
3 Analysis, Budgeting (BUF 101) the following sums, or so much  
4 thereof as may be necessary, to fund for fiscal biennium 2009-  
5 2011 all collective bargaining cost items in the agreement  
6 negotiated with the exclusive bargaining representative of  
7 collective bargaining unit 7:

17 that are not expended or encumbered by June 30, 2010, and  
18 June 30, 2011, of the respective fiscal years, shall lapse as of  
19 those dates.

20 SECTION 9. This Act shall take effect on July 1, 2009.
