# A BILL FOR AN ACT

RELATING TO THE HAWAII HOUSING FINANCE AND DEVELOPMENT  
CORPORATION.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. Chapter 201H, Hawaii Revised Statutes, is  
2 amended by adding to part II a new section to be appropriately  
3 designated and to read as follows:

4           "§201H-           Authority to modify and amend development  
5 agreements with eligible developers. The corporation is  
6 authorized to amend, delete, restate, and otherwise modify the  
7 terms, conditions, plans, specifications, and all other matters  
8 relating, directly or indirectly, to any housing project that  
9 was previously approved by the housing finance and development  
10 corporation, including, without limitation, the terms,  
11 covenants, and conditions of any development agreement for a  
12 housing project between the housing finance and development  
13 corporation and an eligible developer."

14           SECTION 2. Section 201H-4, Hawaii Revised Statutes, is  
15 amended by amending subsection (a) to read as follows:

16           "(a) The corporation may:

17           (1) Sue and be sued;



- 1 (2) Have a seal and alter the same at pleasure;
- 2 (3) Make and execute contracts and other instruments
- 3 necessary or convenient to the exercise of its powers;
- 4 [and]
- 5 (4) Adopt bylaws and rules in accordance with chapter 91
- 6 for its organization, internal management, and to
- 7 carry into effect its purposes, powers, and
- 8 programs [-]; and
- 9 (5) Notwithstanding any law to the contrary, collect fees
- 10 for administrative expenses incurred by the
- 11 corporation to process applications for loans, grants,
- 12 services, and real estate documents related to the
- 13 corporation's functions under this chapter; provided
- 14 that the amount of fees shall be established by the
- 15 legislature."

16 SECTION 3. Section 201H-10, Hawaii Revised Statutes, is  
 17 amended as follows:

- 18 1. By amending subsection (a) to read:
- 19 "(a) The corporation may:
- 20 (1) Obtain the aid and cooperation of governmental
- 21 agencies in the planning, construction, and operation
- 22 of [~~public~~] housing projects and enter into agreements



1 and arrangements as it deems advisable to obtain aid  
2 and cooperation;

3 (2) Arrange or enter into agreements with any governmental  
4 agency for the acquisition of property, options, or  
5 property rights or for the furnishing, installing,  
6 opening, or closing of streets, roads, alleys,  
7 sidewalks, or other places, or for the furnishing of  
8 property, services, parks, sewage, water, and other  
9 facilities in connection with housing projects, or for  
10 the changing of the map of a political subdivision or  
11 the planning, replanning, zoning, or rezoning of any  
12 part of a political subdivision;

13 (3) Procure insurance or guarantees from any governmental  
14 agency for the payment of any debts or parts thereof  
15 incurred by the corporation, including the power to  
16 pay premiums on any such insurance; and

17 (4) Agree to make payments to any state or county agency,  
18 if the agency is authorized to accept payments, as the  
19 corporation deems consistent with the maintenance of  
20 the character of housing projects or the purposes of  
21 this chapter."

22 2. By amending subsection (c) to read:



1           "(c) Any county in which a [~~public~~] housing project is  
2 located or is about to be located may make donations or advances  
3 to the corporation in sums as the county in its discretion may  
4 determine. The advances or donations shall be made for the  
5 purpose of aiding or cooperating in the construction and  
6 operation of the housing project. The corporation, when it has  
7 money available therefor, shall reimburse the county for all  
8 advances made by way of a loan to it."

9           SECTION 4. Statutory material to be repealed is bracketed  
10 and stricken. New statutory material is underscored.

11           SECTION 5. This Act shall take effect on July 1, 2020.
