A BILL FOR AN ACT

RELATING TO MILITARY AFFAIRS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the presence of the 2 United States military in Hawaii contributes to maintaining the 3 peace and stability of the Asia-Pacific region. Further, 4 Hawaii's economy benefits from this presence in that the 5 military expends approximately \$5,600,000,000 annually in Hawaii 6 and provides employment opportunities to approximately one 7 hundred twenty-five thousand residents. Next to tourism, 8 military expenditures are currently the largest source of 9 revenues to Hawaii's economy.

10 The purpose of this Act is to establish a military liaison 11 trust fund to support a nonprofit entity to serve as liaison in 12 matters relating to the military, and to provide oversight for 13 the military's presence in Hawaii and the impact defense 14 spending has on Hawaii's economy.

15 SECTION 2. The Hawaii Revised Statutes is amended by 16 adding a new chapter to be appropriately designated and to read 17 as follows:

5	fund as a separate fund of a nonprofit entity having a board of

adjutant general, with the concurrence of the governor, in their
 sole discretion may rescind the selection of the nonprofit
 entity. If the selection of the entity is rescinded, moneys in
 the military liaison trust fund shall revert back to the State
 and shall be deemed to be state general funds.

6 (c) The nonprofit entity shall serve as liaison for the
7 State in matters relating to the military in Hawaii. The
8 nonprofit entity shall have the following duties and
9 responsibilities:

10 (1) Serve as an advocate for the military and small 11 businesses desiring to do business with the military 12 and other federal agencies where military affairs are 13 concerned;

14 (2) Promote a strong and viable partnership between the
15 state and county governments and the military
16 commands;

17 (3) Build rapport with installation commanders and18 military communities;

19 (4) Facilitate business-development opportunities for
20 small businesses in defense and other federal

Military Liaison Trust Fund; Nonprofit Entity

Description:

Creates the military liaison trust fund within a nonprofit entity to support the nonprofit entity's duties as the state liaison in matters relating to the military. Requires adjutant general, with the governor's concurrence, to select the nonprofit entity. Appropriates funds to the trust fund. Takes effect July 1, 2020. (SD1)
