## HOUSE CONCURRENT RESOLUTION

REQUESTING THE DEPARTMENT OF PUBLIC SAFETY TO IDENTIFY A PLAN TO COLLECT UNADJUDICATED FINES AND TO CONSOLIDATE ITS BACKLOG OF WARRANTS.

1           WHEREAS, the counties are responsible for the enforcement  
2 of the statewide traffic code and county traffic ordinances; and  
3

4           WHEREAS, a substantial portion of the parking and traffic  
5 fine revenues received by the State represents unadjudicated  
6 fines that require little or no expenditure on the part of the  
7 State to collect; and  
8

9           WHEREAS, however, the fines and forfeitures relating to the  
10 commission of traffic violations are paid to the State; and  
11

12           WHEREAS, the cost to the counties of enforcing the traffic  
13 laws is substantial, including the cost of personnel to  
14 administer the laws, issue citations, and make arrests as well  
15 as the costs of equipment and supplies; and  
16

17           WHEREAS, allowing the counties to receive revenues relating  
18 to the commission of traffic violations that are unadjudicated  
19 would greatly assist the counties in offsetting the costs of  
20 enforcing the traffic laws and of managing traffic safety  
21 programs; and

23           WHEREAS, the Governor has indicated support for legislation  
24 that would distribute to the counties a percentage of fines  
25 resulting from traffic and parking citations that are issued by  
26 the counties; now, therefore,

28           BE IT RESOLVED by the House of Representatives of the  
29 Twenty-fifth Legislature of the State of Hawaii, Regular Session  
30 of 2009, the Senate concurring, that the Department of Public



1 Safety is requested to identify a plan to collect unadjudicated  
2 fines and to consolidate its backlog of warrants; and

3  
4 BE IT FURTHER RESOLVED that the Director of Public Safety  
5 is requested to submit findings and recommendations, including  
6 any proposed legislation, to the Legislature not later than  
7 twenty days prior to the convening of the Regular Session of  
8 2010; and

10 BE IT FURTHER RESOLVED that certified copies of this  
11 Concurrent Resolution be transmitted to the Governor and the  
12 Director of Public Safety.
