
HOUSE CONCURRENT RESOLUTION

REQUESTING HAWAII AMERICAN WATER COMPANY TO IMPLEMENT AN ODOR
MITIGATION PLAN FOR ITS FACILITY IN HAWAII KAI.

1 WHEREAS, Hawaii American Water Company (HAWC) is a wholly-
2 owned subsidiary of American Water, the largest and most
3 geographically diverse provider of water services in North
4 America, and provides wastewater service to nearly 35,000 people
5 in Hawaii Kai and along the Kona Coast of the Big Island; and
6

7 WHEREAS, HWAC, a regulated public utility, owns and
8 operates East Honolulu Waste Water Treatment Plant (Treatment
9 Plant) in Hawaii Kai on Oahu; and
10

11 WHEREAS, the Hawaii Kai Neighborhood Board has received
12 numerous complaints regarding excessive offensive odor emissions
13 emanating from the Treatment Plant; and
14

15 WHEREAS, these odors have contributed to a deteriorating
16 standard in the quality of life for both residents of and
17 visitors to Hawaii Kai; and
18

19 WHEREAS, the offensive odor is the result of hydrogen
20 sulfide emissions, and is most noticeable during peak periods of
21 wastewater flow, in the early morning and evening hours; and
22

23 WHEREAS, hydrogen sulfide is linked to several health
24 issues, including eye irritation, respiratory difficulties,
25 vomiting, and nausea; and
26

27 WHEREAS, the stretch of Kalaniana'ole Highway from Hana'uma
28 Bay to Makapu'u, which includes several scenic lookout points,
29 is one of the most pristine drives on Oahu, where residents and
30 visitors alike enjoy views of Hawaii's flora and fauna, but is
31 often tainted by the offensive odors from the Treatment Plant;



1 WHEREAS, the Hawaii Constitution affirms in Article XI,
2 Section 1, that "all public natural resources are held in trust
3 by the State for the benefit of the people," and therefore the
4 State is reminded to "conserve and protect Hawaii's natural
5 beauty"; and
6

7 WHEREAS, HAWC informed the Hawaii Kai Neighborhood Board
8 and community that while it would not be possible to eliminate
9 all odors entirely, the odor problem can be managed by chemical
10 and other means; and
11

12 WHEREAS, there is no government supervision or enforcement
13 of odor mitigation procedures, and it is not known what steps,
14 if any, have been taken at the Treatment Plant to ameliorate the
15 problem; and
16

17 WHEREAS, studies have been conducted examining the issue of
18 odor emission from wastewater treatment plants with recommended
19 odor mitigation solutions, the most recent completed in 2006;
20 and
21

22 WHEREAS, while representatives of HAWC have stated that
23 they have implemented some of the recommendations of the 2006
24 study, they refuse to release the content of the study and the
25 specific steps they have taken to minimize offensive odor
26 emissions; and
27

28 WHEREAS, treatment plants in other areas, including the
29 Orange County Sanitation District in Huntington Beach and
30 Fountain Valley, California which is the third largest treatment
31 facility west of the Mississippi River with more than 50 times
32 the flow capacity of the Treatment Plant, have residential
33 developments immediately adjacent to their facilities and far
34 fewer complaints of offensive odors; now, therefore,

36 BE IT RESOLVED by the House of Representatives of the
37 Twenty-fifth Legislature of the State of Hawaii, Regular Session
38 of 2009, the Senate concurring, that Hawaii American Water
39 Company is requested to develop an odor mitigation plan for the
40 East Honolulu Waste Water Treatment Plant, identifying
41 improvements it will take to mitigate offensive odor emissions,
42 including a timeline for implementation, no later than September
43 2009; and



1 BE IT FURTHER RESOLVED that the Hawaii American Water
2 Company is requested to present the completed plan to the State
3 Senator from the 8th District, State Representative from the 17th
4 District, Honolulu City Councilmember representing District 4,
5 Public Utilities Commission, Department of Health, and Hawaii
6 Kai Neighborhood Board no later than September 2009; and
7

8 BE IT FURTHER RESOLVED that the Public Utilities Commission
9 is requested to review the rates charged by the Hawaii American
10 Water Company and determine whether they are sufficient to
11 adequately upgrade its facilities, including odor mitigation
12 measures, and if so, whether those odor mitigation measures have
13 been implemented; and
14

15 BE IT FURTHER RESOLVED that the Department of Health is
16 requested to monitor the implementation of these odor mitigation
17 measures and to report any progress to the Hawaii Kai
18 Neighborhood board; and
19

20 BE IT FURTHER RESOLVED that certified copies of this
21 Concurrent Resolution be transmitted to the District 4 Honolulu
22 City Councilmember, Director of Health, Chairperson of the
23 Public Utilities Commission, Chairperson of the Hawaii Kai
24 Neighborhood Board, and President of the Hawaii American Water
25 Company.
