## HOUSE CONCURRENT RESOLUTION

REQUESTING THE DEPARTMENT OF LAND AND NATURAL RESOURCES TO  
CONDUCT AN INDEPENDENT APPRAISAL OF MOLOKAI PROPERTIES  
LIMITED LANDHOLDINGS ON THE ISLAND OF MOLOKAI.

1           WHEREAS, Molokai Properties Limited (MPL) is owned by a  
2 foreign company, GuocoLeisure Limited, based in Singapore; and  
3

4           WHEREAS, in April 2008, MPL shut down all of its business  
5 operations on Molokai; and  
6

7           WHEREAS, under orders by the Department of Health, MPL was  
8 required to continue to provide water and sewer services; and  
9

10          WHEREAS, MPL has not made any commitment to continue to  
11 provide water and sewer services and the County of Maui has been  
12 forced to commence litigation against MPL to enforce contracts  
13 to operate and maintain water and wastewater systems for the  
14 protection of the health and safety of its citizens; and  
15

16          WHEREAS, MPL owns over 60,000 acres of land, approximately  
17 one-third of the land on the island of Molokai; and  
18

19          WHEREAS, MPL has engaged in land use practices that have  
20 substantially contributed to the loss of rainforests on its  
21 properties and to the increase of erosion, which depletes the  
22 quality of soil on the land and harms the marine ecosystems  
23 along Molokai's coastline; and

25          WHEREAS, MPL is now denying access to most of its  
26 landholdings to Molokai residents who relied on those lands for  
27 gathering, hunting, and fishing; and

1 WHEREAS, MPL lands contain numerous wahi pana (places of  
2 historical and cultural value), including heiau and ceremonial  
3 sites, ancient taro loi, and loko ia (ancient Hawaiian  
4 fishponds); and

6 WHEREAS, to protect and preserve Hawaii's historic and  
7 cultural heritage, a number of private entities have recently  
8 expressed interest in acquiring all or parts of MPL's  
9 landholdings; and



11 WHEREAS, to negotiate the purchase of any of MPL's  
12 landholdings or to advance any other options or alternatives  
13 with regard to these properties, it is necessary to ascertain  
14 its value; now, therefore,

16 BE IT RESOLVED by the House of Representatives of the  
17 Twenty-fifth Legislature of the State of Hawaii, Regular Session  
18 of 2009, the Senate concurring, that the Department of Land and  
19 Natural Resources is requested to conduct an independent  
20 appraisal of MPL's landholdings on the island of Molokai; and

22 BE IT FURTHER RESOLVED that the appraisal shall be based on  
23 the land classification set by the County of Maui as of January  
24 1, 2009; and

26 BE IT FURTHER RESOLVED that certified copies of this  
27 Concurrent Resolution be transmitted to the Governor and  
28 Chairperson of the Board of Land and Natural Resources.
