10 went on to earn a law degree at the William S. Richardson School  
11 of Law at the University of Hawaii at Manoa, after which he  
12 began working as an attorney in private practice in Honolulu;

15           WHEREAS, REYNALDO D. GRAULTY was elected to the State House  
16 of Representatives in 1982 and again in 1984, beginning his  
17 illustrious career in our State government, also serving his  
18 constituency in The Senate from 1992 to 1996; and

20           WHEREAS, in 1997, REYNALDO D. GRAULTY was appointed by  
21 Governor Benjamin Cayetano to serve as the State Insurance  
22 Commissioner; and

24           WHEREAS, in 1999, REYNALDO D. GRAULTY was appointed to the  
25 Circuit Court of the First Circuit, where he presided over  
26 numerous cases, ensuring that our State laws are interpreted and  
27 applied in a just, equitable, judicious, and prudent manner; and


29           WHEREAS, REYNALDO D. GRAULTY has the distinction of
