
HOUSE RESOLUTION

URGING FAITH-BASED ORGANIZATIONS TO NETWORK AND COOPERATE TO
SUPPORT FOSTER FAMILIES IN HAWAII.

1 WHEREAS, children are our state's most precious resource,
2 making it our greatest interest to nurture and provide them with
3 the opportunities and resources they need to reach their highest
4 potential; and

5
6 WHEREAS, according to the State of Hawaii Department of
7 Human Services (DHS), more than 4,000 children entered foster
8 care in Hawaii in 2006, which constitutes a significant decrease
9 from past years as new and innovative programs have been
10 developed to protect and serve our children and families better;
11 and

12
13 WHEREAS, foster children come from all backgrounds and age
14 groups, from birth to age 18, and 45 percent of foster children
15 are of Hawaiian or part Hawaiian descent; and

16
17 WHEREAS, children enter foster care for various reasons,
18 the most common of which are physical abuse, sexual abuse,
19 domestic violence, and parental drug use; and

20
21 WHEREAS, we have a shared responsibility to serve the needs
22 of foster children and to support the foster families that
23 strive to provide these children with safe, healthy, and loving
24 homes; and

25
26 WHEREAS, as of 2006, there were fewer than 2000 foster
27 homes, representing only a portion of homes that are needed; and

28
29 WHEREAS, Kokua `Ohana, a foster care program that was the
30 result of a collaborative effort between the Partners in
31 Development Foundation and DHS, works with churches and
32 community organizations in the native Hawaiian community to



1 recruit, train, and support foster families through the general
 2 licensing process, with the goal of striving for cultural
 3 harmony within Hawaii's child welfare system by uniting
 4 churches, community organizations, and families to care for and
 5 nurture Hawaii's foster keiki; and

6
 7 WHEREAS, Kokua `Ohana offers to help churches build a
 8 foster family ministry, members of which recruit others to
 9 become foster families, encourage others to become members of
 10 the ministry, support other foster families, accept and
 11 distribute donations, enjoy fellowship activities, mentor new
 12 foster families, help with household projects, and provide
 13 childcare; and

14
 15 WHEREAS, Kokua `Ohana will train foster family ministry
 16 members about foster care and develop an action plan to reach
 17 the hearts of congregations, funnel community donations to
 18 foster families in the church, help build relationships with
 19 local social workers to improve communication and services
 20 provided by the State, and provide support for prospective
 21 foster parents throughout the general licensing process; and

22
 23 WHEREAS, the collaboration of faith-based organizations to
 24 help our children in foster care in such a way would have far-
 25 reaching benefits for society; now, therefore,

26
 27 BE IT RESOLVED by the House of Representatives of the
 28 Twenty-fifth Legislature of the State of Hawaii, Regular Session
 29 of 2009, that faith-based organizations in the state are urged
 30 to network and cooperate to support foster families in Hawaii,
 31 such as by forming foster family ministries; and

 33 BE IT FURTHER RESOLVED that certified copies of this
 34 Resolution be transmitted to the Governor, Director of Human
 35 Services, Director of Kokua `Ohana, Executive Director of Hawaii
 36 Youth Services Network, and President of Family Programs Hawaii.


