## A BILL FOR AN ACT

RELATING TO DISTRICT COURT.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 633-27, Hawaii Revised Statutes, is 2 amended by amending subsection (a) to read as follows: "(a) All district courts, except as otherwise provided, 3 shall exercise jurisdiction conferred by this chapter, and while 4 5 sitting in the exercise of that jurisdiction, shall be known and 6 referred to as the small claims division of the district court; 7 provided that the jurisdiction of the court when sitting as a 8 small claims division of the district court shall be confined 9 to: 10 (1)Cases for the recovery of money only where the amount claimed does not exceed [\$3,500] \$7,000 exclusive of 11 12 interest and costs, except as provided by section 633-13 30; 14 (2) Cases involving disagreement between landlord and 15 tenant about the security deposit in a residential 16 landlord-tenant relationship; and

(3) Cases for the return of leased or rented personal
 property worth [\$3,500] \$7,000 or less where the
 amount claimed owed for that lease or rental does not
 exceed [\$3,500] \$7,000 exclusive of interest and
 costs.

6 This chapter shall not abridge or affect the jurisdiction of the 7 district courts under paragraphs (1) and (3) to determine cases 8 under the ordinary procedures of the court, it being optional 9 with the plaintiff in the cases to elect the procedure of the 10 small claims division of the district court or the ordinary 11 procedures, as provided by rule of court. No case filed in the 12 small claims division after December 31, 1991, shall be removed 13 from the small claims division to be heard under the ordinary 14 procedures of the district court unless the removal is agreed to 15 by the plaintiff. In cases arising under paragraph (2) the 16 jurisdiction of the small claims division of the district court 17 shall be exclusive; provided that the district court, having 18 jurisdiction over a civil action involving summary possession, 19 shall have concurrent jurisdiction with the small claims 20 division of the district court over any security deposit dispute 21 between landlord and tenant in a residential landlord-tenant

relationship. This subsection shall not abrogate nor supersede
 sections 604-5, 633-30, and 633-31."

3 SECTION 2. This Act shall not affect the rights and duties
4 that matured, penalties that were incurred, and proceedings that
5 were begun, before the effective date of this Act.

6 SECTION 3. Statutory material to be repealed is bracketed7 and stricken. New statutory material is underscored.

8 SECTION 4. This Act shall take effect on July 1, 2009.
