RELATING TO COLLECTIVE BARGAINING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 PART I

2 SECTION 1. There are appropriated or authorized from the
3 sources of funding indicated below to program planning,
4 analysis, and budgeting (BUF 101) the following sums or so much
5 thereof as may be necessary to fund for fiscal biennium
6 2009-2011 all collective bargaining cost items in the agreement
7 negotiated with the exclusive bargaining representative of
8 collective bargaining unit 2:


4 SECTION 13. Salary increases and cost adjustments provided

7 shall be paid wholly or proportionately, as the case may be,
8 from the respective funds.

9 SECTION 14. Funds appropriated or authorized by this Act
10 that are not expended or encumbered by June 30, 2010, and
11 June 30, 2011, of the respective fiscal years, shall lapse as of
12 those dates.

13 SECTION 15. This Act shall take effect on July 1, 2009.
