A BILL FOR AN ACT

RELATING TO COLLECTIVE BARGAINING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 PART I

2 SECTION 1. There are appropriated or authorized from the
3 sources of funding indicated below to program planning,
4 analysis, and budgeting (BUF 101) the following sums or so much
5 thereof as may be necessary to fund for fiscal biennium
6 2009-2011 all collective bargaining cost items in the agreement
7 negotiated with the exclusive bargaining representative of
8 collective bargaining unit 9:


2 SECTION 13. Salary increases and cost adjustments provided

5 shall be paid wholly or proportionately, as the case may be,
6 from the respective funds.

7 SECTION 14. Funds appropriated or authorized by this Act
8 that are not expended or encumbered by June 30, 2010, and June
9 30, 2011, of the respective fiscal years, shall lapse as of
10 those dates.

11 SECTION 15. This Act shall take effect on July 1, 2009.
