SENATE CONCURRENT RESOLUTION

URGING THE SUPERINTENDENT OF EDUCATION TO ESTABLISH AND FACILITATE A SPECIAL EDUCATION PRIVATE SCHOOL TASK FORCE TO ADVISE THE DEPARTMENT OF EDUCATION ON POLICIES OR PROCEDURES FOR OVERSIGHT AND MONITORING OF PRIVATE SCHOOL OR FACILITY PLACEMENTS.

1 WHEREAS, pursuant to section 302A-436, Hawaii Revised
2 Statutes, the Department of Education has a clearly defined duty
3 toward exceptional children, including providing instruction,
4 special facilities, and special services for education, therapy,
5 and training to enable them to live normal competitive lives;
6 and

8 WHEREAS, in order to effectively accomplish this purpose,
9 the Department is required to establish and administer
10 instruction, special facilities, and special services for the
11 education, therapy, and training of exceptional children, and
12 provide in connection therewith corrective therapy, together
13 with academic, occupational, and related training; and

15 WHEREAS, this program shall include boarding facilities,
16 when necessary, special classes in schools or homes, and other
17 facilities as shall be required to render appropriate services
18 to the exceptional child; and

20 WHEREAS, pursuant to section 302A-443, Hawaii Revised
21 Statutes, the Department of Education has the authority to
22 "exercise oversight and monitoring of any child who has
23 undergone unilateral special education placement as soon as
24 practicable after the placement"; now, therefore,

26 BE IT RESOLVED by the Senate of the Twenty-fifth
27 Legislature of the State of Hawaii, Regular Session of 2009, the
28 House of Representatives concurring, that the Superintendent of
29 Education is urged to establish and facilitate a Special
30 Education Private School Task Force to:

- 7 oversight and monitoring; and

12 BE IT FURTHER RESOLVED that the Special Education Private
13 School Task Force members include:

- 14 (1) A representative from the Department of Education;

- 16 (2) A representative from the Special Education Advisory
- 17 Council;
- 18
- 19 (3) The senior hearings officer from the Department of
- 20 Commerce and Consumer Affairs, Office of
- 21 Administrative Hearings, or a designee;
- 22
- 23 (4) A representative from the Hawaii Association of
- 24 Independent Schools;
- 25
- 26 (5) A representative from the University of Hawaii,
- 27 College of Education, Special Education;
- 28
- 29 (6) A representative administrator from a public school
- 30 with experience with private school placements; and

- 32 (7) A representative administrator from a public charter
- 33 school; and

36 BE IT FURTHER RESOLVED that the Special Education Private
37 School Task Force select a Chairperson by a majority of votes of
38 its members; provided that the Chairperson shall be a member
39 other than an employee of the Department of Education; and

41 BE IT FURTHER RESOLVED that the Special Education Private
42 School Task Force submit a report of its findings and
43 recommendations to the Legislature no later than twenty days
44 prior to the convening of the Regular Session of 2011, reporting
