begs leave to report as follows:


Your Committee received testimony from the Department of Commerce and Consumer Affairs and Associated Builders and Contractors of Hawaii. A written statement was received from the nominee. Written testimony presented to the Committee may be reviewed on the Legislature's website.

Upon review of the testimony, your Committee finds that this nominee for reappointment to the Board of Electricians and Plumbers is a diligent and contributing member who devotes additional time outside of Board meetings to review applications. Your Committee notes that the nominee is both a licensed plumber and an employer, doing business as a plumbing contractor. Your Committee finds that the nominee has dedicated himself to the advancement of the profession, including by serving as a teacher in an apprenticeship program, participating in a continuing competency program for licensees, and actively participating in professional organizations.
