The purpose of this bill is to support programs that benefit
Hawaiians and native Hawaiians by appropriating funds for the
operating and capital improvement budgets of the Office of
Hawaiian Affairs.

The Association of Hawaiian Civic Clubs and Native Hawaiian
Legal Corporation supported this bill. The Office of Hawaiian
Affairs, Papa Ola Lokahi, and Na Pua No'eau supported this bill
and suggested amendments.

Your Committee made technical, nonsubstantive amendments to
this bill for clarity, consistency, and style.

As affirmed by the record of votes of the members of your
Committee on Hawaiian Affairs that is attached to this report,
your Committee is in accord with the intent and purpose of H.B.
No. 900, as amended herein, and recommends that it pass Second
Reading in the form attached hereto as H.B. No. 900, H.D. 1, and
be referred to the Committee on Finance.


