HAWAII'S PUBLIC POLICY CENTER TO MEET WITH, AND ADOPT THE
RECOMMENDATIONS OF THE KANAKA MAOLI COMMITTEE WITH RESPECT TO
THE CENTER'S REVIEW OF THE 2050 SUSTAINABILITY PLAN,"

begs leave to report as follows:

The purpose of this concurrent resolution is to request that
the University of Hawaii's Public Policy Center, as it reviews and
develops data sources and benchmarks for the major goals of the
2050 Sustainability Plan, meet with and adopt the recommendations
of the Kanaka Maoli Committee.

The University of Hawaii at Manoa opposed this measure. The
University of Hawaii's Social Sciences Public Policy Center
submitted comments.


Your Committee recognizes the concerns of UH concerning the
current fiscal situation and likely budget reductions for UH over
the next two fiscal years, but believes that the recommendations
of the Kanaka Maoli Committee are an essential component of a
successful 2050 Sustainability Plan.
