Your Committee on Hawaiian Affairs, to which was referred
H.C.R. No. 271 entitled:

"HOUSE CONCURRENT RESOLUTION URGING THE GOVERNOR AND THE
LEGISLATURE TO REQUEST AND PROVIDE FOR SUFFICIENT FUNDING FOR
THE DEPARTMENT OF HAWAIIAN HOMESTEADS,"

begs leave to report as follows:

The purpose of this concurrent resolution is to release the
Department of Hawaiian Home Lands (DHHL) from the burden of
raising revenues through Hawaiian home lands leases to non-
beneficiaries, by urging the Governor and the Legislature to
acknowledge its constitutional duty to provide DHHL with
sufficient sums to fund its programs, loans, and administrative
and operating budget.

The Native Hawaiian Legal Corporation and several concerned
individuals supported this measure.

Your Committee has amended this measure by:

- (1) Amending the title to read: "HOUSE CONCURRENT RESOLUTION
URGING THE GOVERNOR AND THE LEGISLATURE TO REQUEST AND
PROVIDE FOR SUFFICIENT FUNDING FOR THE DEPARTMENT OF
HAWAIIAN HOMELANDS";
- (2) Adding the Association of Hawaiian Civic Clubs, Royal
Order of Kamehameha I, `Iho`ulaokalani Coalition, Hale O
