Your Committee on Economic Revitalization, Business, & Military Affairs, to which was referred H.C.R. No. 42 entitled:

"HOUSE CONCURRENT RESOLUTION REQUESTING THE DEPARTMENT OF DEFENSE TO ALLOW AVAILABLE SURPLUS HELICOPTERS TO BE USED FOR MEDICAL EVACUATION SERVICES,"
