Your Committee on Human Services, to which was referred H.C.R. No. 46 entitled:

"HOUSE CONCURRENT RESOLUTION URGING CONGRESS TO PROTECT FUNDING AND MAINTAIN PROGRAMS, LAWS, REGULATIONS, AND POLICIES THAT ASSIST VICTIMS OF DOMESTIC VIOLENCE,"

The purpose of this concurrent resolution is to provide support to victims of domestic violence by urging the United States Congress to maintain funding and programs that assist victims of domestic violence.
