Your Committee on Human Services, to which was referred
H.C.R. No. 46 entitled:

"HOUSE CONCURRENT RESOLUTION URGING CONGRESS TO PROTECT
FUNDING AND MAINTAIN PROGRAMS, LAWS, REGULATIONS, AND
POLICIES THAT ASSIST VICTIMS OF DOMESTIC VIOLENCE,"

begs leave to report as follows:

The purpose of this measure is to urge Congress to preserve
funding and maintain programs, laws, regulations, and policies
that assist victims of domestic violence.

Testimony in support of this measure was submitted by the
Hawaii State Coalition Against Domestic Violence and three
individuals. Written testimony presented to the Committee may be
reviewed on the Legislature's website.

Your Committee finds that domestic violence continues to be a
major problem in Hawaii and that funding should be preserved to
maintain programs and develop and enforce laws and policies that
assist victims of domestic violence.

Your Committee has amended this measure by making technical,
nonsubstantive changes for the purposes of clarity and
consistency.

As affirmed by the record of votes of the members of your
Committee on Human Services that is attached to this report, your
Committee concurs with the intent and purpose of H.C.R. No. 46, as

amended herein, and recommends its adoption in the form attached hereto as H.C.R. No. 46, S.D. 1.


