Your Committee on Water, Land, & Ocean Resources, to which was referred H.R. No. 149 entitled:

"HOUSE RESOLUTION REQUESTING THE OFFICE OF THE GOVERNOR TO CONVENE A SCENIC BYWAYS WORKING GROUP TO SELECT POSSIBLE SITES STATEWIDE, INCLUDING THE PI`ILANI TRAIL ON MAUI, FOR PROPOSED FEDERAL DESIGNATION AS SCENIC BYWAYS,"

Historic Hawaii Foundation and a concerned individual supported this resolution. The Department of Transportation (DOT) supported the intent of this resolution.


Your Committee has amended this resolution by:
