Your Committee on Transportation, to which was referred H.R. No. 247 entitled:

"HOUSE RESOLUTION REQUESTING THE DEPARTMENT OF TRANSPORTATION TO ENCOURAGE EACH HOLDER OF A CONCESSION CONTRACT AT A STATE AIRPORT TO GIVE FIRST RIGHT OF REFUSAL TO LOCAL VENDORS TO SUPPLY GOODS, WARES, MERCHANDISE, AND SERVICES TO THE CONCESSION,"
