Your Committee on Ways and Means, to which was referred
S.C.R. No. 108, S.D. 1, entitled:

"SENATE CONCURRENT RESOLUTION REQUESTING THE FORMATION OF A
JOINT LEGISLATIVE PROCUREMENT WORKING GROUP TO EVALUATE THE
STATE PROCUREMENT CODE AND RECOMMEND IMPROVEMENTS,"

begs leave to report as follows:

The purpose of this measure is to form a joint legislative
procurement working group to evaluate the state procurement code,
recommend improvements, and report its findings to the
Legislature.

Your Committee received one written comment on this measure.
The written comment may be reviewed on the Legislature's website.

Your Committee finds that the Hawaii Procurement Code and its
accompanying administrative rules result in a complex process that
often results in needless delays in the awarding of public
contracts. Your Committee further finds that the procurement
process should be streamlined and serve as a vehicle for providing
an economic advantage to local businesses. The procurement code
is in need of review by a joint legislative procurement working
group to find efficiencies and to improve its effectiveness.

Your Committee has amended this measure by making a technical
nonsubstantive amendment for the purposes of clarity and style.


