Your Committee on Human Services, to which was referred
S.C.R. No. 80 entitled:

"SENATE CONCURRENT RESOLUTION URGING NONPROFIT ORGANIZATIONS
AND COMMUNITY GROUPS TO ESTABLISH SAFETY PROCEDURES FOR
ROADSIDE SOLICITATION OF FUNDS AND DONATED GOODS,"

begs leave to report as follows:

The purpose of this senate concurrent resolution is to urge
nonprofit organizations and community groups to establish safety
procedures for the roadside solicitation of donations.

A concerned individual provided testimony in support of this
measure.

Your Committee finds that the solicitation of roadside
donations has increased over the past few years. Many of these
instances are "accidents waiting to happen," so a set of safety
procedures for this type of solicitation is crucial to protect
many of the volunteers that lend their time to collect donations.

As affirmed by the record of votes of the members of your
Committee on Human Services that is attached to this report, your
Committee concurs with the intent and purpose of S.C.R. No. 80 and
recommends that it be referred to the Committee on Transportation.
