HB 240 Status	MAKING A GRANT-IN-AID APPROPRIATION TO THE COUNTIES TO FINANCE DROUGHT MITIGATION PROJECTS AND MEASURES. Appropriates funds to the counties for drought mitigation purposes.	AGR, FIN
HB 255 Status	RELATING TO AGRICULTURE. Directs department of agriculture, in conjunction with agribusiness development corporation, to develop an agricultural water plan for Ka`u and south Kona.	AGR, FIN
