<u>HB 563, HD1</u> <u>(HSCR556)</u> Status	RELATING TO INTOXICATING LIQUOR. Requires class 5 dispenser liquor licensees to carry liability insurance as a condition of acquiring, transferring, and renewing a license. (HB563 HD1)	EBM, CPC
<u>HB 197</u> <u>(HSCR298)</u> Status	RELATING TO CONDOMINIUMS. Gives boards of directors authority to install or allow the installation of solar energy or wind energy devices on the common elements of condominiums.	EEP, CPC
<u>HB 875</u> Status	RELATING TO CONDOMINIUMS. Extends the condominium dispute resolution pilot project until 6/30/11.	CPC
<u>HB 876, HD1</u> <u>(HSCR315)</u> Status	RELATING TO CONDOMINIUMS. Increased the maximum amount of the special assessment for delinquent monthly common assessments that can be charged against a person who purchases a condominium unit. Expands limitations on association liability for elderly unit owners or residents aging in place to include disabled persons. (HB876 HD1)	HUS, CPC

DECISION MAKING TO FOLLOW

Persons wishing to offer comments should submit testimony at least 24 hours prior to the hearing with a transmittal cover indicating:

- The Committee the comments are directed to;
- The date and time of the hearing;



- Measure number; and
- The number of copies the Committee is requesting.

While every effort will be made to copy, organize, and collate all testimony received, materials received on the day of the hearing or improperly identified or directed to the incorrect office, may be distributed to the Committee after the hearing.
