SB 591, SD1 (SSCR586) Status

#### RELATING TO INSURANCE.

Requires insurers that offer health care coverage to the regular employees of any group or association to offer the same coverage to part time employees working at least 15 hours per week. Requires the insurance commissioner to report to the legislature on cost-benefit. (SD1)
