RELATING TO EDUCATION.

EDH/HMS

Establish in statutes the state advisory panel, as required by the reauthorized Individuals with Disabilities Education Act, by designating the existing special education advisory council as the state advisory panel, with new members to be appointed by the governor; requires annual report.

Decision Making to follow, if time permits.

When faxing, please indicate to which committee the testimony is being submitted and the date and time of the hearing.
