<u>SB 1268</u> <u>Testimony</u> <u>Status</u>	RELATING TO AFFORDABLE HOUSING. Permits the department of Hawaiian home lands to receive and subsequently assign, transfer, or exchange county affordable housing credits.	WTL/EDH, TIA
<u>SB 729</u> <u>Testimony</u> <u>Status</u>	RELATING TO RENTAL HOUSING. Increases permanently the percentage of the conveyance tax paid into the rental housing trust fund from the current allocation of thirty per cent to sixty-five per cent.	EDH/WTL, WAM
<u>SB 1350</u> <u>Testimony</u> <u>Status</u>	RELATING TO KAKAAKO. Increases the reserved housing requirement for a planned development on a lot of at least 1 acre in the Kakaako community development district, mauka area.	EDH/WTL, JGO
<u>SB 1277</u> <u>Testimony</u> <u>Status</u>	RELATING TO HOUSING. Increases incentives for the development of affordable housing in Hawaii.	EDH/WTL, WAM
