Amends the law mandating solar water heater systems for single-family dwellings by clarifying its application to new dwellings and clarifying variance request procedures and authority. Effective 1/1/2050. (SD2)

RELATING TO HOUSEHOLD ENERGY DEMAND.

EEP/HSG, FIN

Allows for the use of clotheslines at any privately owned single-family residential dwelling or townhouse. Allows reasonable restrictions on the use of clotheslines for aesthetic purposes. (SD2)



DECISION MAKING TO FOLLOW


Testimony submitted will be placed on the Legislative Web site after the hearing adjourns. This public posting of testimony on the Web site should be considered when including personal information in your testimony.
