<u>HB 949</u> <u>(HSCR577)</u> <u>Status</u>	RELATING TO THE HAWAIIAN HOMES COMMISSION ACT. Authorizes the department of Hawaiian home lands to issue long term commercial leases.	HAW/WLO, FIN
<u>HB 1809, HD1</u> <u>(HSCR103)</u> <u>Status</u>	RELATING TO RECYCLING. Establishes a television recycling and recovery program.	EEP/EBM, FIN
<u>HB 268, HD1</u> <u>(HSCR439)</u> <u>Status</u>	RELATING TO LAND COURT. Requires the assistant registrar of the land court to provide, within 10 days and free of charge, an image and index of all instruments that contain real property transactions each week to the administrator of the city and county of Honolulu's real property assessment division. <u>HB 269, HD1</u> <u>(HSCR591)</u> <u>Status</u>	RELATING TO REAL PROPERTY. Requires the registrar of the bureau of conveyances to provide, within 10 days after the end of each week and free of charge, the administrator of the real property assessment division of the City and County of Honolulu an image and index of all instruments and documents that have been recorded in the registrar's office that week relating to land in all the counties. Requires the real property assessment administrator of the City and County of Honolulu to provide copies of the images, without charge, to the real property assessment administrators of the other counties. Status

RELATING TO PAYDAY LENDING.
Requires check cashing (deferred deposit) businesses to post and provide consumers with rate, fee, and other information, provides for payment plans; eliminates exemption from law of retailers who occasionally cash checks. Effective 01/01/2020.

(HSCR492)
Status

RELATING TO INSURANCE.
Makes various clarifying and technical amendments, and corrects inadvertent errors, in the Life Settlements Model Act, chapter 431E, HRS, which establishes consumer protections in life settlement transactions. Effective 01/01/2020.


