SB 705 Testimony Status	RELATING TO HAWAII PUBLIC PROCUREMENT CODE. Exempts GSA-approved sole source vendors on procurements involving federal matching funds from certain sole source procurement provisions.	JGO
SB 1661 Testimony Status	RELATING TO PUBLIC AGENCY MEETINGS. Clarifies permissible attendance and procedures for board members to attend meetings of other boards, departments, agencies, and hearings of the legislature.	JGO
SB 176 Testimony Status	RELATING TO INFORMATION PRACTICES. Authorizes the office of information practices to fine any agency that does not comply with a decision; requires the office to adopt rules that set uniform standards for issuing fines.	JGO
SB 1646 Testimony Status	RELATING TO FREEDOM OF INFORMATION. Allows the office of information practices to enforce chapter 92, public agency meetings and records. Allows OIP to waive fees to access government records if public interest is served by a waiver.	JGO
SB 1652 Testimony Status	RELATING TO GOVERNMENT RECORDS. Requires government agencies to file and comply with a retention schedule of government records. Clarifies the definition of government record.	JGO
