RELATING TO SERVICE OF PROCESS.

JUD/CPC

Requires association of apartment owners of a condominium or the Board of Directors of a planned community association to designate a representative on the property that is authorized to provide entry for a duly authorized process server.

DECISION MAKING TO FOLLOW

Persons wishing to offer comments should submit testimony at least 24 hours prior to the hearing with a transmittal cover indicating:

- Testifier's name with position/title and organization;
- The Committee the comments are directed to;
- The date and time of the hearing;
- Measure number; and
- The number of copies the Committee is requesting.


