HB 510 Status	RELATING TO ELECTIONS. Extends the filing deadline by 5 days in cases where a candidate withdraws less than 5 days prior to the filing deadline.	JUD
HB 613 Status	RELATING TO ELECTIONS. Requires the office of elections to develop a standard withdrawal and declaration of candidacy form by 01/01/2010. Requires a candidate to file the standard form to withdraw as a candidate prior to the subsequent filing of nomination papers for any other elective office.	JUD
