<u>HB 954, HD1</u> <u>(HSCR877)</u> <u>Testimony</u> <u>Status</u>	RELATING TO A MAJOR DISASTER RESERVE TRUST FUND. Establishes the major disaster reserve trust fund. Takes effect July 1, 2020. (HB954 HD1)	PSM, WAM
<u>HB 1713, HD2</u> <u>(HSCR815)</u> <u>Testimony</u> <u>Status</u>	RELATING TO HAZARDS. Allows Civil Defense, when no emergency exists, to enter on private property to mitigate hazardous situations after giving the landowner notice. May seek recovery and reimbursement of costs and expenses. (HB1713 HD2)	PSM, JGO
<u>HB 1568, HD1</u> <u>(HSCR880)</u> <u>Testimony</u> <u>Status</u>	MAKING AN APPROPRIATION FOR THE AMERICAN RED CROSS. Makes an appropriation to the state department of defense to assist the American Red Cross, Hawaii Chapter, with needed capital improvement projects. Effective July 1, 2020. (HB1568 HD1)	PSM, WAM
<u>HB 358, HD1</u> <u>(HSCR914)</u> <u>Testimony</u> <u>Status</u>	RELATING TO DRUG TREATMENT. Authorizes placement of certain offenders in secure drug treatment facilities. (HB358 HD1)	PSM, JGO
<u>HB 413, HD1</u> <u>(HSCR874)</u> <u>Testimony</u> <u>Status</u>	RELATING TO PUBLIC SAFETY. Establishes a state residential drug abuse program with an in-community component to help inmates' reentry into the community upon their release from prison. Expands number of transition beds in module nineteen at the Oahu community correctional center. Effective 07/01/2020. (HB413 HD1)	PSM, WAM

<p><u>HB 519, HD1</u> <u>(HSCR915)</u> <u>Testimony</u> <u>Status</u></p>	<p>RELATING TO INMATES. Requires return of all out-of-state inmates in private prisons by 12/31/2015. Requires the public safety department to plan, design, and construct sufficient facilities to house inmates in Hawaii by 12/31/2015.</p>	<p>PSM, WAM</p>
<p><u>HB 1152, HD1</u> <u>(HSCR917)</u> <u>Testimony</u> <u>Status</u></p>	<p>RELATING TO COMMITTED PERSONS' ACCOUNTS. Amends section 353-20, Hawaii Revised Statutes, to permit the Director of Public Safety to direct the department to have one or more accounts for committed persons. Also states that the accounts are non-interest bearing and that no interest can be paid to committed persons on the individual accounts. Effective July 1, 2025. (HB1152 HD1)</p>	<p>PSM, WAM</p>

When faxing, please indicate to which committee the testimony is being submitted and the date and time of the hearing.

Please note: If you submit your written testimony after 4:00 p.m. the day prior to the hearing, a copy of your testimony may not be available during the hearing but will be posted online for the public after the hearing.
